Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Health Protection (Coronavirus, International Travel) (Amendment No. 11) Regulations (Northern Ireland) 2020 and shall come into operation at 4.00 am on 19th September 2020.

(2) In these Regulations, “the principal Regulations” means the Health Protection (Coronavirus, International Travel) Regulations (Northern Ireland) 2020 ^{M3}.

 - (b) omit “Guadeloupe” and “Slovenia”.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Health Protection (Coronavirus, International Travel) Regulations (Northern Ireland) 2020 (“The principal Regulations”).

Singapore and Thailand are added to the list of countries and territories in Schedule 3 to the principal Regulations exempt from the requirement in regulation 4 of those Regulations to self-isolate for 14 days after arrival in Northern Ireland.

Guadeloupe and Slovenia are omitted from the list of countries and territories in Schedule 3 to the principal Regulations exempt from the requirement in regulation 4 of those Regulations to self-isolate for 14 days after arrival in Northern Ireland.
