**The Parking Places on Roads (Coaches) (Amendment) Order
(Northern Ireland) 2020**

Made - - - - - *9th December 2020*

Coming into operation - - - - - *11th January 2021*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

It appears to the Department to be necessary to provide suitable parking places for coaches on the lengths of road specified in Article 2.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking place the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representations have been received.

Citation and commencement

1. This Order may be cited as The Parking Places on Roads (Coaches) (Amendment) Order (Northern Ireland) 2020 and shall come into operation on 11th January 2021.

Amendments

2.—(1) The Parking Places on Roads (Coaches) Order (Northern Ireland) 2015^(d) is amended in accordance with paragraphs (2) to (3).

(2) In Schedule 1 add the following item—

- “3. Merchants Quay, Newry (north-west side) – from a point 30 metres south-west of its junction with Monaghan Street for a distance of 35 metres in a south-westerly direction.”

(3) In Schedule 3 add the following items—

- “3. Stranmillis Road, Belfast (north-east side) – from a point 127 metres south-east of its junction with University Road for a distance of 29 metres in a south-easterly direction.
4. Water Street, Londonderry (south-east side within a lay-by) – from a point 18 metres north-east of its junction with Foyle Street for a distance of 37 metres in a north-easterly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places on Roads (Coaches) Order (Northern Ireland) 2015 (“the Order”) by the addition to Schedule 1 of the item relating to Merchants Quay, Newry (Article 2(2)) and by the addition to Schedule 3 of the items relating to Stranmillis Road, Belfast and Water Street, Londonderry (Article 2(3)).

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with The Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the roads.
