# The Drumnagoon Road and Kernan Hill Road, Portadown (Abandonment) Order (Northern Ireland) 2020

Made - - - - 11th June 2020

Coming into operation - 3rd July 2020

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993(b) and now vested in it(c).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic to abandon the areas of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

#### Citation, commencement and interpretation

- 1.—(1) This Order may be cited as The Drumnagoon Road and Kernan Hill Road, Portadown (Abandonment) Order (Northern Ireland) 2020 and shall come into operation on 3rd July 2020.
- (2) In this Order "the Developer" means Antrim Construction Company whose registered office is situated at 130 140 High Street, Holywood, BT18 9HW.

#### **Application**

- **2.** The Developer shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on completion of the works the areas of road described in the Schedule shall be abandoned.
- **3.**—(1) All existing cables, wires, mains, pipes or other apparatus owned by BT Group plc placed along, across, over or under the abandoned areas of road shall be removed.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes and other apparatus shall be extinguished.

- **4.**—(1) All other existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned areas of road shall be retained.
- (2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.

Article 2

## AREAS OF ROAD TO BE ABANDONED

Two areas of road totalling 1336.6 square metres of road at Drumnagoon Road and Kernan Hill Road, Portadown consisting of—

- (a) 515.5 square metres of Drumnagoon Road, Portadown extending from its junction with Kernan Hill Road for a distance of 59.9 metres in an easterly direction; and
- (b) 821.1 square metres of Kernan Hill Road, Portadown extending from its junction with Drumnagoon Road for a distance of 83.3 metres in a southerly direction;

more particularly delineated and shown hatched and coloured red on map number IN1/19/303676.
