# The Loading Bays on Roads (Amendment) Order (Northern Ireland) 2021

Made - - - - 3rd February 2021

Coming into operation - 24th February 2021

The Department for Infrastructure(a) makes the following Order in exercise of the powers conferred by Articles 10(4) and 13(1) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the road specified in Article 2.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

#### Citation and commencement

**1.** This Order may be cited as The Loading Bays on Roads (Amendment) Order (Northern Ireland) 2021 and shall come into operation on 24th February 2021.

#### **EXPLANATORY NOTE**
