**ENVIRONMENTAL PROTECTION**

**The Producer Responsibility Obligations (Packaging Waste) (Amendment) Regulations (Northern Ireland) 2023**

*Made* - - - - *26 October 2023*  
*Coming into operation* *1 January 2024*

The Department of Agriculture, Environment and Rural Affairs makes these regulations in exercise of the powers conferred by section 50 of, and paragraphs 1(1) and 2(2) of Schedule 4 to, the Environment Act 2021 (“the Act”)(1) and now vested in it(2).

The Department of Agriculture, Environment and Rural Affairs makes these Regulations after consultation in accordance with paragraph 8 of Schedule 4 to the Act and is satisfied as to the matters specified in paragraph 9(1) of that Schedule.

**Citation and commencement**

1. These Regulations may be cited as the Producer Responsibility Obligations (Packaging Waste) (Amendment) Regulations (Northern Ireland) 2023 and come into operation on 1st January 2024.

**Amendment of the Producer Responsibility Obligations (Packaging Waste) Regulations (Northern Ireland) 2007**

2.—(1) The Producer Responsibility Obligations (Packaging Waste) Regulations (Northern Ireland) 2007(3) are amended as follows.

(2) In Schedule 2 (recycling obligations)—

(a) for paragraph 5 substitute—

“5. The percentage which is prescribed as the recycling target “X” for the year 2024 is 80%.”;

(b) in paragraph 6, for Table 2 substitute—

(1) 2021 c. 30.

(2) The Department of the Environment was dissolved by section 1(9) of the Departments Act (Northern Ireland) 2016 and, by virtue of Article 8(1)(c) of the Departments (Transfer of Functions) Order (Northern Ireland) 2016, its functions for the purposes of these Regulations were transferred to the Department of Agriculture, Environment and Rural Affairs

(3) S.R. 2007 No. 198; relevant amendments are S.R. 2017 No. 3, S.R. 2017 No. 230, S.R. 2020 No. 345 and S.R. 2022 No. 286.

## EXPLANATORY NOTE

*(This note is not part of these Regulations)*

These Regulations amend the Producer Responsibility Obligations (Packaging Waste) Regulations (Northern Ireland) 2007 ([S.I. 2007 No. 198](#)) (the “2007 Regulations”). The 2007 Regulations impose on producers the obligation to recycle packaging waste in order to attain the recycling targets set out in Article 6(1) of European Parliament and Council [Directive 94/62/EC](#) on packaging and packaging waste (OJ No L 365, 31.12.94, p10), as last amended by Directive (EU 2018/852).

These Regulations set an overall recycling target as well as material-specific recycling targets for 2024 on obligated producers in Northern Ireland in relation to glass, plastic, aluminium, steel, paper/board, and wood.
