

Any person so arrested may, on the order of the civil authority, be detained either in any of His Majesty's prisons or elsewhere, as may be specified in the Order, upon such conditions as the civil authority may direct, until he has been discharged by direction of the Attorney-General or is brought before a Court of Summary Jurisdiction. Any person to be brought before a Court under this regulation shall receive at least twenty-four hours notice in writing of the nature of the charge preferred against him.

REGULATION DATED THE 27TH DAY OF APRIL, 1922, UNDER THE CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922, REQUIRING INHABITANTS TO REMAIN INDOORS.

1922. No. 31.

Whereas certain regulations for Peace and Order in Northern Ireland are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by Sub-section (3) of Section 1 of the said Act, that the Minister of Home Affairs shall have power to make Regulations—

- (a) for making further provision for the Preservation of the Peace and Maintenance of Order; and
- (b) for varying or revoking any provision of the Regulations, whether contained in the said Schedule or made as aforesaid.

And that any regulations made as aforesaid shall, subject to the provisions of the said Act, have effect and be enforced in like manner as regulations contained in the said Schedule :

Now therefore, I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, by this Regulation do make further provision for the preservation of the Peace and maintenance of Order, and do vary the provision of the regulation hereinafter mentioned as follows, that is to say—the following provision shall be added to and form part of the Regulation number I, contained in the said Schedule, and the said Regulation shall have effect and be construed accordingly :—

For the purpose of this Regulation a person within such area shall be deemed to be or to remain out between such hours if he is found between such hours elsewhere than at his usual place of abode.

Provided that a person shall not be deemed to be or to remain out between such hours if he is found in a hotel or registered lodging house in which he is duly registered according to law, or if he has given previous notice to the police at the police station nearest to the house at which he intends to stay, of his intention to stay therein.

REGULATIONS DATED 6TH JULY, 1922, UNDER THE CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922, MAKING FURTHER PROVISION FOR THE PRESERVATION OF THE PEACE AND MAINTENANCE OF ORDER.

Whereas certain Regulations for Peace and Order in Northern Ireland are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by Sub-section (3) of Section 1 of the said Act that the Minister of Home Affairs shall have power to make Regulations (a) for making further provision for the preservation of the Peace and Maintenance of Order, and (b) for varying or revoking any provision of the Regulations, whether contained in the said Schedule, or made as aforesaid, and that any Regulations made as aforesaid shall, subject to the provisions of the said Act have effect and be enforced in like manner as Regulations contained in the said Schedule.
