NATIONAL HEALTH INSURANCE AND UNEMPLOYMENT INSURANCE (INSPECTORS' CERTIFICATES) REGULATIONS (NORTHERN IRELAND), DATED DECEMBER 19TH, 1923, MADE BY THE MINISTRY OF LABOUR UNDER SECTION 112 (5) OF THE NATIONAL INSURANCE ACT, 1911 (1 & 2 GEO. 5, c. 55) AND SECTION 29 (5) OF THE UNEMPLOYMENT INSURANCE ACT, 1920 (10 & 11 GEO. 5, c. 30).

The Ministry of Labour, by virtue of the powers conferred on them by the National Health Insurance Acts (Northern Ireland), 1911 to 1922, and the Unemployment Insurance Acts (Northern Ireland), 1920 to 1922, and all other powers enabling, hereby make the following Regulations :—

1. These Regulations may be cited as the National Health Insurance and Unemployment Insurance (Inspector's Certificates) Regulations (Northern Ireland), 1922.

2. The certificate of appointment to be furnished under Sub-section 5 of Section 112 of the National Insurance Act, 1911, and under Sub-section (5) of Section 29 of the Unemployment Insurance Act, 1920, to an Inspector appointed for the purposes of the said Acts, shall be in the form set out in the Schedule to these Regulations.

3. The National Health Insurance (Inspectors' Certificates) Regulations (Ireland), 1913, and the Unemployment Insurance (Inspectors) Regulation, 1920, to the extent to which those Regulations are in force in Northern Ireland are hereby revoked.

Form of Certificate of Appointment of Inspector.

National Health Insurance Acts (Northern Ireland), 1911 to 1922.

Unemployment Insurance Acts (Northern Ireland), 1920 to 1922.

To all whom it may concern :

Take Notice that in accordance with the provisions of the National Health Insurance Acts (Northern Ireland), 1911 to 1922, and the Unemployment Insurance Acts (Northern Ireland), 1920 to 1922..... (whose signature appears hereon) has been duly appointed an Inspector for the purposes of the said Acts. The said Inspector has power for the purposes of the execution of the Acts, namely :—

- (a) To enter at all reasonable times any premises or place, other than a private dwelling house not being a workshop, where he has reasonable grounds for supposing that any employed contributors or any employed persons are employed ;
- (b) To make such examination and inquiry as may be necessary for ascertaining whether the provisions of the said Acts are complied with in any such premises or place ;
- (c) To examine, either alone or in the presence of any other person as he thinks fit, with respect to any matters under the Acts, every person whom he finds in any such premises or place, or, whom he has reasonable cause to believe to be or to have been an employed contributor or an employed person, and to require every such person to be so examined, and to sign a declaration of the truth of the matters in respect of which he is so examined.
- (d) To exercise such other powers as may be necessary for carrying the said Acts or any of them into effect.

The occupier of any such premises or place and any other person employing any employed contributor or employing any employed person, and the servants and agents of any such occupier or other person and any employed contributor or any employed person shall furnish to any inspector all such information and shall produce for inspection all such registers, books, cards, wages sheets, records of wages, and other documents as the inspector may reasonably require : Provided, that no one shall be required to answer any question or give any evidence tending to incriminate himself.

PEACE PRESERVATION.

Arrest and Detention of Suspected Persons.

REGULATION DATED 20TH MAY, 1922, UNDER THE CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922, PROVIDING FOR THE ARREST AND DETENTION OF SUSPECTED PERSONS.

1922. No. 34.

Whereas certain Regulations for Peace and Order in Northern Ireland are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by Sub-section (3) of Section 1 of the said Act that the Minister of Home Affairs shall have power to make Regulations—

- (a) for making further provision for the preservation of the Peace and Maintenance of Order ; and
- (b) for varying or revoking any provision of the Regulations, whether contained in the said Schedule or made as aforesaid.

And that any Regulations made as aforesaid shall, subject to the provisions of the said Act, have effect and be enforced in like manner as regulations contained in the said Schedule :

Now, therefore, I, the Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, by this Regulation do make further provision for the Preservation of the Peace and Maintenance of Order, and do vary the provision of the regulation hereinafter mentioned as follows, that is to say—The second clause of Regulation 23 is hereby revoked and the following clause is substituted therefor, and the said regulation shall have effect and be construed accordingly :—

(b) he lost his employment through his misconduct, or
 (c) he left his work voluntarily without just cause,
 shall not be regarded as genuinely seeking whole-time employment but unable to obtain such employment for an additional period equal to the length of the statutory disqualification : provided that the additional period of disqualification shall not be applicable if, in the opinion of the Committee an applicant has been engaged in bona-fide employment subsequent to the date of the expiration of the period of the Statutory disqualification.
