# OLD AGE PENSIONS. Consolidated Regulations.

MADE BY THE MINISTRY OF FINANCE FOR NORTHERN IRELAND IN CONJUNCTION WITH THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND HEREBY IN PURSUANCE OF THE OLD AGE PENSIONS ACTS, 1908 TO 1919 (a) AND THE BLIND PERSONS ACT, 1920 (b).

1924. No. 55.

GENERAL PROVISIONS.

1. These Regulations may be cited as the Old Age Pensions Short Title. Consolidated Regulations (N.I.), 1925.

2.-(1) In these Regulations, unless the context otherwise requires

Interpre: tation.

"The Act of 1908" means the Old Age Pensions Act, 1908, "the Act of 1911" means the Old Age Pensions Act, 1911, "the Act of 1919" means the Old Age Pensions Act, 1919, "the Act of 1920" means the Blind Persons Act, 1920, and "the Acts" means the Old Age Pensions Acts, 1908 to 1919, and the Blind Persons Act, 1920:

"The Ministry" means the Ministry of Home Affairs for Northern Ireland acting as the Central Pension Authority within the meaning of the Act of 1908, and "the Ministry of Finance" means the Ministry of Finance for Northern Ireland :

(a) 8 E. 7. c. 40; 1-2 G. 5. c. 16; 9-10 G. 5. c. 102. (b) 10-11 G. 5. c. 49.

"The committee" means the local pension committee under the Act of 1908, and includes, with regard to any matter delegated to a sub-committee under sub-section (2) of section 8 of that Act, the sub-committee to which the matter is delegated :

"The pension officer" means the pension officer to whom any claim or question is referred, and includes any pension officer acting for or in succession to that pension officer:

"Paying Officer" means such officer as may be appointed or designated by the Ministry of Finance for the purpose of the exercise and performance of the powers and duties which, immediately before the 1st day of December, 1921, were exercised and performed by Officers of the Post Office, and includes any of such last mentioned officers who may be authorised to act as Paying Officers in pursuance of arrangements made under Section 63 of the Government of Ireland Act, 1920, for the exercise and performance by such Officers of the aforesaid powers and duties on behalf of the Ministry of Finance :

" District" means the area for which any pension officer is appointed to act :

"Pension" means an old age pension under the Acts :

"Claim" means a claim to a pension :

"Claimant" means a person by whom a claim has been made:

"Pensioner" means a person in receipt of a pension.

(2) References in these regulations to enactments of the Parliament of the United Kingdom shall be construed as references to those enactments as they apply in Northern Ireland.

(3) The Interpretation Act, 1921, (a) applies for the purpose of the interpretation of these Regulations as it applies for the purpose of the interpretation of an Act of the Parliament of Northern Ireland.

3.—(1) Any notice or other document required or authorised to be sent for the purpose of these Regulations shall be in writing.

(2) Any notice or other document required or authorised to be sent to any person for the purpose of these Regulations shall be deemed to be duly sent if sent by post addressed to that person at his ordinary address or, in the case of a committee or subcommittee, addressed to the clerk of the committee or sub-committee at his usual office.

4. The forms set out in the First Schedule to these Regulations, or forms to the like effect, shall be used in all cases to which those forms are applicable.

MAKING OF CLAIMS.

5.—(1) Every person who desires to make a claim must fill up a form of claim, and deliver the form when filled up either to (a) 12 Geo. 5. c. 4. (N.1).

Provisions as to sending of notices.

Method of making claim. Form No. 1 the paying officer or to the pension officer.\*

(2) The Ministry of Finance shall cause printed forms of claim to be furnished to every Paying Officer and every Paying Officer shall, on application being made to him for the purpose, supply a form of claim gratis to any person who desires to make a claim.

(3) Every paying officer shall, if any person who desires to make a claim requests him so to do, give to that person such information and such assistance in filling up the form of claim as is in his power to give and as may be necessary to enable that person to fill up the form properly.

6.—(1) Every paying officer upon delivery to him of a claim to a pension shall, unless he has received from the committee appointed for the area in which the claimant resides directions that claims shall be sent to the committee, forthwith send the claim to the pension officer :

Provided that if the committee give any such directions as aforesaid, the paying officer shall instead of sending the claim to the pension officer send it to the committee, or where the committee have appointed a sub-committee for the area in which the claimant resides, and the committee have sent notice to the paying officer requiring him so to do, shall send the claim to the sub-committee instead of to the committee.

(2) As soon as may be after the receipt thereof, any claim so sent to a committee or sub-committee shall be transmitted by the committee or sub-committee to the pension officer.

## Investigation and Determination of Claims by Pension Officers and Committees.

7.—(1) The pension officer shall keep a register of all claims referred to him, and on receiving any claim shall, subject to these Regulations, forthwith cause the claim to be registered in such manner as the Ministry of Finance prescribes, and shall number all claims consecutively in the order in which they are entered in the register.

(2) The pension officer shall also enter in the register of claims such particulars as the Ministry of Finance prescribes of every decision of the committee or of the Ministry on, or in reference to, any claim entered in his register; or on, or in reference to, any question raised in connection with any pension allowed on any such claim; or on, or in reference to, any application made for the revocation or alteration of the provisional allowance of a claim.

Investigation of claim by pension officer. 8.—(1) As soon as may be after receiving any claim, the pension officer shall take all necessary steps for investigating the claim for the purpose of ascertaining whether the claimant is entitled to a pension, and if he is so entitled, to what rate of pension :

Provided that :---

- (a) where a claim previously made by the claimant within six months of his present claim has been disallowed and the claimant does not satisfy the pension officer that there is a *prima facie* reason to believe that the ground on which the former claim was disallowed is no longer in operation; or
- (b) where a claim on the face of it discloses that the claimant does not fulfil the statutory conditions ;

the pension officer shall not be bound to investigate the claim, but in any case in which the pension officer decides under this provision not to investigate a claim he shall make a special report to the committee stating his reasons for not investigating the claim, and shall then, if so requested by the committee, investigate the claim.

(2) Subject to compliance with the instructions set out in the Second Schedule to these Regulations and to any further instructions issued for the guidance of pension officers, the pension officer shall investigate the claim in such manner as he thinks best fitted for the purpose.

Reports of pension officer on claims: Form No 2. 9.—The pension officer shall send to the committee his reports on any claims investigated by him, and any special reports on any claims which he has decided not to investigate, on such date or dates in each month as the Ministry of Finance may direct for the purpose, and shall annex to every report sent by him to the committee the original claim and (except in the case of a special report) a statement of the enquiries made by him in reference to the claim and of the result of those inquiries, and, unless he is satisfied that the yearly means of the claimant do not exceed £26 5s. and so states in the report, a summary of the income, property, and other yearly means of the claimant.

Meetings for consideration of claims.

10.—(1) Not later than seven days after the receipt of the report of the pension officer on any claim a meeting of the committee shall be held for the purpose of considering the claim.

If, by reason of a quorum of the committee not being present the meeting cannot be held upon the day fixed for the purpose, it shall stand adjourned till the same day in the following week or such earlier day as may be fixed for holding the adjourned meeting by a majority of the members of the committee present, and if no quorum of the committee is present on the day to which the meeting so stands adjourned, it shall again stand adjourned till the same day in the next week or such earlier day as may be fixed as aforesaid and so from time to time; Provided that a committee need not hold a meeting more often than once a month.

(2) At the meeting held for the consideration of a claim the committee shall consider the claim together with the report of the pension officer and any other evidence or information laid before them, and the committee may at any time, if they think necessary, require the pension officer to procure any further information which it is in his power to procure and which is not procurable by the claimant, in reference to any matter to be considered by the committee.

(3) The pension officer shall be entitled to attend any meeting held for considering any claim and to speak but not to vote thereat.

11.—Not less than three clear days before the day of any meeting (including an adjourned meeting) at which any claims are to be considered, the committee shall send to the pension officer a notice stating that a meeting for the consideration of claims will be held on that day, and specifying, so far as is then known, the claims which will be considered at that meeting.

12.—In any case in which the pension officer has reported that the claim may properly be allowed at the maximum rate of pension and the committee after considering the claim agree with the report of the pension officer, the committee shall forthwith allow the claim and send notice of their decision to the pension officer and the claimant.

13.—(1) In any case in which the pension officer has reported that the claim cannot properly be allowed, or can only be allowed at less than the maximum rate or from a date subsequent to the date of the receipt of the claim, or the date on which the claimant contends that he attained the age of 70 (or 50 in the case of a blind person), whichever is later, the committee shall, not less than two clear days before the date of the meeting at which the claim is to be considered, send to the claimant a notice of the meeting, stating the grounds upon which the pension officer has reported that, in his opinion, a pension should be refused or should only be allowed at less than the maximum rate or from a date subsequent to the date of the receipt of the claim or the date on which the claimant contends that he attained the statutory age, and also affording the claimant an opportunity of being heard at the meeting :

Provided that where the report of the pension officer on any claim is received by the committee too late to enable them to send a notice of the meeting to the claimant they may nevertheless consider the claim if they are satisfied that it is in the interests of the claimant that the claim should be considered forthwith.

(2) If on considering any claim the committee disagree as respects any matter with the report of the pension officer, or if they consider that for any other reason the claim requires further consideration, the committee shall not proceed to give their final decision on the claim without such further investigation as the committee think necessary.

(3) The committee, may, if necessary for the purpose of any further investigation, or of giving a claimant an opportunity or a further opportunity of being heard, adjourn the consideration of any claim, and where the consideration of any claim is so adjourned, an adjourned meeting for the further consideration of the claim shall be held not more than five weeks after the date of the original meeting, and the committee shall send notice to the claimant of the adjournment of the consideration of the claim, and of the day fixed for the further consideration of the claim.

(4) The claimant shall, if he so desires, be entitled to attend and be heard at any such adjourned meeting.

(5) The committee shall, as soon as may be, give their decision on every claim which falls to be determined by them under this Regulation, and shall forthwith after giving their decision send notice thereof to the pension officer and to the claimant.

(6) In any case in which a claim is disallowed, the notice of the decision of the committee to be sent to the claimant under this Regulation shall state the grounds upon which the claim has been disallowed, and in any case in which a claim is disallowed or is allowed at less than the maximum rate, the notice shall state that the claimant is entitled to appeal to the Ministry against the decision of the committee.

14. In any case where a claim is allowed, the committee must fix the weekly rate of pension to which the pensioner is entitled and specify the rate in the notice of their decision.

15.—(1) If it appears to any person that, although for the time being he is not entitled to a pension, he will nevertheless become entitled to a pension at some future date, he may make a claim at any time not more than four months before that future date.

(2) If the committee are satisfied that a claimant is likely, at any time within four months from the date on which the claim is being considered, to be entitled to a pension, they may allow the claim provisionally so as to take effect on any future date not later than four months from the date of their decision, or where a claimant is in receipt of disqualifying poor relief, so as to take effect from a certain date or any subsequent date not later than four months from the date of the decision, subject to the cessation of disqualifying poor relief.

# PROVISIONS AS TO QUESTIONS AND APPLICATIONS.

16.—(1) If any pensioner desires to raise any question as to the weekly rate of his pension, or if any person whose claim has been provisionally allowed desires to make an application for the alteration of the provisional allowance, he may do so by sending a written statement of the question or the application, as the case may be, together with a summary of any evidence in support of his allegations, to the pension officer of the district in which he usually resides, and the pension officer shall investigate and (subject to the provisions of this Regulation) report on the question or application in the same manner *mutatis mutandis* as he is by these Regulations required to do in the case of a claim :

Provided that the pension officer shall not be bound to investigate the question or application in any case in which the evidence adduced by the pensioner in support of his allegations is not, in the opinion of the pension officer, substantial, and less than six months have elapsed since the pension was granted or since a similar question was determined by the committee, but if in pursuance of this provision the pension officer decides not to investigate the question or application, he shall make a special report to the committee stating shortly the grounds of his opinion.

(2) The date on which the written statement of the question is received by the pension officer shall be deemed to be the date on which the question is raised.

(3) If a pension officer himself desires to raise any question as to the fulfilment or the continuance of the fulfilment of the statutory conditions, as to the disqualification of a pensioner, as to the weekly rate of the pension of any pensioner, or as to the receipt at any time by a person of a pension when he was not entitled to receive the pension or of a pension at a rate at which he was not entitled to receive it, or to make an application for the alteration or revocation of the provisional allowance of a claim for a pension, he may do so by sending notice of the question or application, as the case may be, to the committee, and the date on which notice of the question is so sent shall be deemed to be the date on which the question is raised.

The pension officer shall submit to the committee his report on every question raised, or application made, by him either at the time when he sends to the committee notice of the question or application, or as soon as may be thereafter.

The pension officer shall take into consideration any representation which may be made by any person that any such question as aforesaid ought to be investigated, or any such application made, and shall, if he considers it necessary so to do, investigate and raise the question, or make the application, accordingly.

(4) Where the committee receive a report of the pension officer as respects any such question or application as aforesaid, they shall *mutatis mutandis* consider and determine the question

or application in the same manner as, and send all such notices as they are by these Regulations required to do and to send in the case of a claim :

Provided that in any case where a question raised relates to a person, who, having been a pensioner, is dead, any notice required under these Regulations to be given to the pensioner shall be given to his personal representative or, if there is no such personal representative, to such person as the committee may direct in that behalf, and the legal personal representative, or the person to whom the notice is directed to be given, shall have the same right to be heard and to appeal to the Ministry against the decision of the committee as the pensioner would have had.

(5) Where payment of a pension is discontinued under subsection (4) of Section 6 of the Act of 1911, upon the raising of a question as to the disqualification of the pensioner, the pension officer shall send a notice to the pensioner informing him that payment of the pension will be stopped pending the decision of the question.

(6) If it appears at any time that a pensioner who is in receipt of a pension at a certain rate will at some future date become entitled to a pension at a higher or a lower rate, a question as to the rate at which the pension should as from that future date be paid may be raised either by the pensioner or the pension officer at any time not more than four months before that future date, and if it appears to the committee that the pension will become payable at some different rate at some time within four months from the date on which the question was raised, the committee may provisionally determine that the pension shall, as from some specified date, not being more than four months later than the date on which the question was raised, be paid at a specified different rate, and any such provisional determination shall, as from the specified date, unless previously revoked or altered, take effect according to the terms thereof.

## APPEALS.

Provisions as to time and manner of appeal, &c. Form No. 9. 17.—(1) A pension officer or any person aggrieved who desires to appeal to the Ministry against a decision of the committee may do so by sending to the Ministry notice of appeal within seven days after the date of the decision, or, if appellant is a person to whom notice of the decision is required to be sent under these Regulations, within seven days after the receipt of the notice by him:

Provided that if in any case it is shown to the Ministry by any person desiring to appeal that it was not reasonably practicable for him to send notice of appeal within the time herein before limited the Ministry may in their discretion, notwithstanding that the notice of appeal has not been sent within the said time, entertain the appeal if the notice is sent at any time within fourteen days after the receipt of the notice of the decision.

(2) The person appealing must, at the time of sending his notice of appeal to the Ministry, also send to the committee a notification that he has so appealed, and the committee shall forth-Form No. 10. with after receiving the notification send to the Ministry—

- (a) The notification of appeal;
- (b) The claim or the statement of the question or application in respect of which the appeal is brought ;
- (c) The report of the pension officer;
- (d) A statement of the decision of the committee and in any case in which the committee disagree with the report of the pension officer, a statement of the grounds of their decision;
- (e) All other documents in the possession of the committee relating to the claim, question or application.

(3) Where the appeal is brought by any person other than a claimant or a pensioner (including a person in whose case a pension has been provisionally allowed), the committee shall send notice to the claimant or pensioner informing him that the appeal has been brought, and where the appeal is brought by any person other than the pension officer, the committee shall send a like notice to the pension officer.

(4) The clerk of the committee shall supply gratis to any person desiring to appeal a form of notice of appeal and a form of notification to the committee of an appeal having been made.

18.—(1) In the case of any appeal to the Ministry the Ministry shall cause such inquiry to be held, or take such other steps as they think necessary for the purpose of enabling them to come to a proper decision on the case.

(2) Notice of every decision of the Ministry shall forthwith be sent to the committee and to the pension officer and the committee shall on receiving any such notice send information thereof to the claimant or pensioner (including a person in whose case a pension has been provisionally allowed), and likewise, if the appellant is a person other than the pension officer or a claimant or pensioner, to the appellant.

# Applications to Ministry where Committee Refuse or Neglect to Determine Matter.

19.—(1) An application to the Ministry under paragraph (d) of sub-section (1) of section 7 of the Act of 1908, as amended by subsection (6) of section 6 of the Act of 1911, by any person aggrieved by the refusal or neglect of a committee to consider a claim, or to determine any question or application, may be made by sending to the Ministry a notice in writing stating that the applicant is so aggrieved, and specifying the date on which the claim or application was made or the question referred to the committee, as the case may be.

(2) If the Ministry do not consider that the committee have refused or neglected to consider the claim, or determine the question or application, within a reasonable time, the Ministry shall inform the applicant accordingly.

(3) The provisions of these Regulations relating to the procedure of the Ministry on appeals shall apply in the case of applications to the Ministry under the above-mentioned provision of the Act of 1908, as so amended, as they apply in the case of appeals to the Ministry.

## LOCAL PENSION COMMITTEES AND SUB-COMMITTEES.

20.-(1) A local pension committee shall consist of such number of persons, not being less than seven nor more than the number of the council by whom the committee is appointed, as the council may determine.

(2) The council by whom a committee is appointed may make regulations as to the quorum, proceedings, and place of meeting of the committee, but subject to any such regulations, the quorum, proceedings, and place of meeting of the committee shall be such as the committee determine :

Provided that the quorum shall in no case be less than three.

(3) The term of office of a person appointed to be a member of a committee shall be three years or such less term as may be fixed by the appointing council at the time of the appointment, and any person on ceasing to be a member of a committee may be re-appointed :

Provided that—

- (a) if any person so appointed is a member of the appointing council, he shall cease to be a member of the committee if he ceases to be a member of that council;
- (b) a member of the committee may resign by sending to the clerk of the appointing council notice of his desire so to do;
- (c) a member whose office expires by effluxion of time shall continue to hold office until his successor is appointed;
- (d) the appointing council may, if they think fit, at any time remove any member of a committee and appoint another person to be a member of the committee in his place;
- (c) if a member of the committee is absent from meetings of the committee for more than six months consecutively, except in case of illness or for some reason approved by the committee, his office shall on the expiration of those months become vacant.

(4) If any vacancy occurs in a committee by death, resignation, or otherwise, the clerk of the committee shall forthwith send notice of the vacancy to the clerk of the appointing council, and that council shall as soon as possible fill up the vacancy.

(5) A committee shall appoint some member of the committee to be chairman of the committee, and the person so appointed shall, if he so long remains a member of the committee, hold office as chairman for such period, not being less than 12 months, as may be specified in the resolution of the committee under which he is so appointed.

(6) Every question at a meeting of the committee shall be determined by a majority of the votes of the members of the committee present and voting on the question, and, in case of an equal division of votes, the chairman of the meeting shall have a second or casting vote.

(7) The proceedings of a committee shall not be invalidated by any vacancy in their number or by any defect in the appointment of any member of the committee.

21.-(1) A committee shall, for the purpose of any of the meetings of the committee under these Regulations, be entitled to use free of charge (except such charge as may be approved by the Ministry of Finance for heating, lighting, or cleaning), at all reasonable times, and after reasonable notice, any offices of any local authority situate in the area of the council by which the committee is appointed.

(2) If any question arises under this Regulation it may be determined by the Ministry.

(3) If in any case there are no offices of any local authority available for use by a committee and the committee are unable to obtain the use of any room free of charge, the committee may hire such room as may be required for the purpose of any meeting of the committee :

Provided that :---

- (a) the cost of hiring any such room shall not exceed the scale fixed for the purpose by the Ministry of Finance;
- (b) except with the sanction of the Ministry (which sanction shall only be given when no other suitable room is available either free of charge or at a cost not exceeding such scale as aforesaid) a committee shall not hold a meeting on any licensed premises nor shall any such premises be used without such sanction as an office of the committee or for any purpose of or incidental to the business of the committee.

(4) In this Regulation the expression "committee" (except where the context otherwise requires) includes a sub-committee, and the expression "licensed premises" means premises licensed

Use by committees of offices of local authorities, and provisions in case there are no such offices available. for the sale of intoxicating liquor, and includes any club at which intoxicating liquor is supplied,

22.—(1) Every committee shall appoint some fit person to be clerk of the committee, to hold office during the pleasure of the committee.

> (2) The committee may assign to the clerk such remuneration as the committee think fit, not being in excess of the scale fixed for the purpose by the Ministry of Finance.

> (3) The clerk of every committee shall keep a record in such form and containing such particulars as the Ministry direct of all claims, applications, and questions in respect of which a report is sent to the committee by the pension officer, and of the decision of the committee thereon.

> (4) The clerk of every committee shall immediately upon his appointment notify the appointment, together with his name and address, to the Ministry and to the Ministry of Finance or any Department of the Government of the United Kingdom the officers of which are acting on behalf of the Ministry of Finance in the administration of these Regulations by virtue of arrangements made under Section 63 of the Government of Ireland Act, 1920.\*

> (5) In this regulation the expression " committee " includes a sub-committee, except that in the case of the clerk to a subcommittee the remuneration shall be assigned by the committee.

> 23.-(1) Every committee by whom a sub-committee is appointed shall send notice of the appointment to the Ministry and to every pension officer acting within the sub-committee's district, and the notice so sent shall specify the area for which the sub-committee is appointed to act, and shall state which of the powers and duties of the committee have been delegated to the sub-committee.

> (2) A sub-committee shall consist of such number of members, not being less than five nor more than nine, as the committee may determine :

> Provided that the Ministry may in special circumstances substitute a smaller or a greater number as the minimum or maximum number respectively of a sub-committee.

> (3) Subject as aforesaid, the provisions of these Regulations relating to the constitution, chairman, and proceedings of committees shall apply to sub-committees as they apply to committees with the substitution of the committee for the appointing council and of the sub-committee for the committee.

## MISCELLANEOUS.

24. The Ministry or any committee may for the purpose of determining any claim, question, or application which is to be determined by the Ministry or the committee, have regard to any such evidence or information as in the opinion of the Ministry or committee is sufficient for the purpose, and is the best evidence or information which it is reasonably possible to obtain.

25. Any failure on the part of any pension officer or any committee to comply with any requirements of these Regulations or of any directions given by virtue of these Regulations as to the time within which any proceedings are to be taken, or any things are to be done, or as to the notice to be given of meetings for the consideration of claims, shall not of itself render invalid the decision of the committee on any claim, question, or application.

26. As soon as may be after the decision of the committee on any claim, question, or application has become final, the committee shall return the claim, question or application, and all documents relating thereto in their possession to the pension officer.

27.(1) It shall be the duty of the pension officer, in every case in which there is a final decision allowing a claim, to issue to the claimant a book of pension orders.

(2) On every issue to a pensioner of a fresh book of pension orders he shall be required to sign a statement in writing in the Form No. 16 in the First Schedule to these Regulations.

28. Subject to the provisions of the Acts and of these Regulations, every person appointed as a pension officer shall, in the execution of his office, observe and follow the orders, instructions, and directions of the Ministry of Finance and of any Department of the Government of the United Kingdom acting on behalf of the Ministry of Finance in the administration of these Regulations by virtue of arrangements made under Section 63 of the Government of Ireland Act, 1920.\*

29. For the purpose of enabling a pension officer to ascertain whether any claimant or pensioner is disqualified, by reason of being an inmate of any workhouse or other poor law institution, for receiving or continuing to receive a pension, or to ascertain the yearly means of any claimant or pensioner, every officer or person acting in the administration of the relief of the poor shall, if so requested by the pension officer, supply to the pension officer such information as it is in his power to give as respects any person who is or has been an inmate of a workhouse or other poor law institution, or is or has been otherwise in receipt of poor relief.

Authentication of, and furnishing of, copies of decisions. 30.-(1) A copy of a decision of a committee shall be authenticated by the signature of the clerk, or the person for the time being acting as clerk of the committee; and a copy purporting to be signed by the clerk or person so acting as clerk, shall, until the contrary is proved, be deemed to have been so signed.

(2) The committee shall, on the demand of any person interested and on payment to the clerk of the committee of such fee (not exceeding sixpence per copy) as the committee may fix, furnish to that person a duly authenticated copy of any decision of the committee.

**31.**—When a person in receipt of a pension is liable to repay any sums under sub-section (2) of section 9 of the Act of 1908, as amended by the Act of 1911, and the Ministry of Finance under sub-section (3) of section 7 of the Act of 1911, direct those sums or any part of them to be deducted from the sums to which that person becomes entitled on account of a pension the deduction shall be made by withholding payments on account of the pension until the total of the sums withheld amounts to the total of the sums so directed to be deducted.

32.—(1) Where any person, being either a person who is alleged to be entitled to a pension or a person by whom or on whose behalf a claim has been made or a pensioner, is by reason of any mental or other incapacity unable to act and no committee or quasi-committee of his estate has been appointed, an application may be made in accordance with the provisions of this regulation to the local pension committee for the appointment of a person (whether the applicant or any other person) to exercise on behalf of the person unable to act any right to which that person may be entitled under the Acts, and to receive on behalf and for the benefit of that person any sums which may become payable to that person by way of a pension.

(2) On any such application as aforesaid the local pension committee may, if they are satisfied that the person proposed to be appointed is a fit and proper person to act for the purposes of this Regulation on behalf of the incapacitated person and is willing so to act, appoint him to act accordingly:

Provided that—

- (a) no person being a member, officer or servant of the local pension committee and no person under 18 years of age shall be capable of being appointed to act under this Regulation;
- (b) the local pension committee may at any time in their absolute discretion revoke any appointment made under this Regulation ; and
- (c) any person appointed under this Regulation, may, on giving the local pension committee one month's notice of his intention so to do, resign his office.

(4) Every person intending to make an application under this Regulation shall give notice in writing of his intention to the clerk of the local pension committee specifying the name and address of the incapacitated person in respect of whom the application is to be made and the name, address and description of the person proposed to be appointed, and the clerk shall, as soon as may be, send to the intending applicant a notification of the date on which the application will be considered by the local pension committee.

(5) Where an appointment is made of a person to act under this Regulation, or where any such appointment is revoked, or a person appointed so to act resigns his office, the clerk of the local pension committee shall, as soon as may be, send to the pension officer a notification of the appointment, revocation, or resignation, as the case may be, and of the date as from which it takes effect ; and where any such appointment is made or revoked, he shall also send a notification to the person who is appointed or whose appointment is revoked.

33.— These Regulations shall come into operation on the 1st February, 1925.

34.— The Old Age Pensions Regulations, 1911, and the Old Age Pensions Regulations, 1920, are hereby revoked as respects Northern Ireland :

Provided that anything done in pursuance of those Regulations shall, notwithstanding anything in these Regulations, be deemed to have been validly done and shall have full effect accordingly.

Nore.---1. A person in order to fulfil the statutory conditions for the receipt of a pension must-

- (i) Have reached the age of 70.
- (ii) Be a British subject, or if the wife, or the divorced wife, or the widow of an alien, have been a British subject up to the time of her marriage.
- (iii) Have had his residence in the United Kingdom for not less than 12 years since attaining the age of 50 years if he is a natural-borh British subject, or for not less than 20 years is he is not a natural-born British subject. Residence in the United Kingdom means residence in Northern Ireland or in Great Britain or partly in Northern Ireland and partly in Great Britain, and (in addition to certain periods men-tioned in the proviso to s. 3 (2) of The Old Age Pensions Act, 1911) any periods spent in the portion of Ireland comprised in the Irish Free State before the establishment of that State (6th Dec., 1922) count towards the necessary residence qualification.

N.B.—In the case of a person who is so blind as to be unable to perform any work for which eyesight is essential, "50" should be substituted for "70" in (i) and "30 years" for "50 years" in (iii).

2. A person is disqualified for the receipt of a pension in the following cases :--

1. While he is in receipt of poor relief as an inmate of any workhouse or other poor-law institution unless he has become an inmate for the purpose of obtaining medical or surgical treatment, in which case he is not disqualified for a period of three months from the date of admission provided that he so long continues to require such treatment.

2. While he is in prison under a sentence of imprisonment without the option of a fine, or under a sentence of penal servitude.

If an order of a court disqualifying him is in force.

4. While he is detained in any asylum within the meaning of the Local Government (Ireland) Act, 1898, or while he is being maintained in any place as a pauper or criminal lunatic.

Note,-The means of a person who is one of a married couple living together in the same house is deemed to be half the total means of the couple.

## SECOND SCHEDULE.

# INSTRUCTIONS TO PENSION OFFICER AS TO INVESTIGATION OF CLAIMS AND QUESTIONS.

(1) For the purpose of determining the age of any person, regard may be had to any of the following, viz. :—

Certificate of birth;

Certificate of baptism;

Certificate of service in any of the forces of the Crown;

Certificate of membership of any friendly or provident society or trade union;

Certificate of marriage;

Any other evidence which appears sufficient for the purpose

(2) Where it appears that any person was born in the British Dominions and has not resided out of the British Dominions during the preceding twenty years, he may, unless there is reason to suspect the contrary, be taken as being a British subject.

(3) If it appears that any person was not born in the British Dominions, he may prove that he is a British subject either by producing a naturalization certificate and showing that he is the person referred to in the certificate or by showing that his father was a British subject.

If a person who alleges that he was naturalized is unable to produce a naturalization certificate, enquiry may be made at the Home Office as to whether the person is on the Register of Naturalized Aliens.

If any person alleges that though born out of the British Dominions he was the child of a British father, he should be required, if possible, to show whether his father and his grandfather were born in the British Dominions.

(4) For the purpose of determining whether a person has been resident in Great Britain, or Northern Ireland, during any part of the Statutory period, or (prior to 6th Dec., 1922) in the portion of Ireland now comprised in the Free State, he must be required to give, if possible, a reference to two persons who have known him, and to state what his employment, if any, has been, during the period of residence.

(5) For evidence as to blindness in the case of persons applying under the Blind Persons Act, 1920, regard may be had to the following, viz. :--

Certificate from the authorities of an approved school for the blind that the claimant was educated as a blind person at the school ;

Certificate that the claimant was employed as a blind person at an approved workshop for the blind ;

Certificate by the Authorities of an approved agency for the blind that the claimant is known to them as blind ;

Any other evidence which appears sufficient for the purpose.

(6) In any case in which the Pension Officer thinks it desirable so to do, he may reduce to writing any question which he desires to put to any person and the answer given by that person to the question, and may require that person to sign the answer, or may require any person to fill up and sign any form and the person shall sign the answer or fill up the form accordingly.

(7) The Pension Officer shall in every case take all reasonable steps to obtain the best evidence and information which it is reasonably possible to obtain, and make all such inquiries as appear to him necessary having regard to the circumstances of the case.
