Compensation Agreements.

MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER SECTION 16 (1) (c) OF THE NATIONAL HEALTH INSURANCE ACT, 1924 (14 & 15 Geo. 5, c. 38).

1924. No. 88.

The Ministry of Labour for Northern Ireland, in pursuance of the powers conferred on it by paragraph (c) of sub-section (1) of Section 16 of the National Health Insurance Act, 1924 (14 & 15 Geo. 5. c. 38), hereby makes the following Regulations:—

- 1. These Regulations may be cited as the National Health Insurance (Compensation Agreements) Regulations, (Northern Ireland), 1924, and shall come into operation on the 1st day of January, 1925.
- 2.—(1) In these Regulations, unless the context otherwise requires— $\,$
 - "The Act" means the National Health Insurance Act, 1924 (14 & 15 Geo. 5. c. 38).

"The notice" means the notice of an agreement required to be sent by an employer under paragraph (c) of subsection (1) of Section 16 of the Act.

- (2) The Interpretation Act, 1889, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.
- 3. The time within which the notice is to be sent by the employer shall be seven days from the date of the making of the agreement to which the notice relates.
- 4. The notice shall contain the particulars specified, in the Schedule to these Regulations, or such of those particulars as are appropriate to the particular case.
- 5. The National Health Insurance (Compensation Agreements) Regulations (Ireland), 1915 (S. R. & O., 1915, No. 1193), are hereby revoked, without prejudice to the validity of any notice given thereunder.
