Contributory Pensions, Joint Committee.

MADE BY THE MINISTRY OF LABOUR UNDER SECTION 32 OF THE Widows', Orphans' and Old Age Contributory Pensions ACT (NORTHERN IRELAND), 1925.

1925. No. 117.

The Ministry of Labour in exercise of the powers conferred on it by Section 32 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925, and with the consent of the National Health Insurance Joint Committee hereby makes the following Regulations:-

- 1. These Regulations may be cited as the Contributory Pensions (Joint Committee) Regulations (Northern Ireland), 1925.
- 2.—(1) In these Regulations, unless the context otherwise requires-

"The Act" means the Widows', Orphans' and Old Age

Contributory Pensions Act (Northern Ireland), 1925;

- "The Joint Committee" means the National Health Insurance Joint Committee;
- (2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.
- 3.—(1) For the purposes of the provisions of the Act specified in the first column of the First Schedule to these Regulations, the Joint Committee alone shall exercise the powers specified in the third column of the said Schedule, and set opposite to the provisions to which they respectively relate.

- (2) For the purposes of the provisions of the Act specified in the first column of the Second Schedule to these Regulations, the Joint Committee shall exercise jointly with the Ministry of Labour the power specified in the third column of the said Schedule and set opposite to the provisions to which they respectively relate.
- 4. The Joint Committee shall exercise, either alone or jointly with the Ministry of Labour, as the case may require, the power of making orders under Section 36 of the Act, if and in so far as those orders relate to any powers which under the provisions of these Regulations are to be exercised by the Joint Committee alone or by the Joint Committee jointly with the Ministry of Labour.
