

1. This Order may be cited as the National Health Insurance (Teachers) Order (Northern Ireland), 1925.

2. The Interpretation Act, 1921, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The classes of teachers set forth in the Schedule to this Order are specified as being classes in the case of which the conditions of employment are similar to the conditions of employment prevailing in the case of teachers falling within the exceptions at paragraph (f) of Part II of the First Schedule to the National Health Insurance Act, 1924.

SCHEDULE.

- (i) Teachers to whom the Teachers (Secondary and Preparatory) Superannuation Scheme, 1925, applies.
- (ii) Lay Assistant Teachers and Junior Assistant Mistresses in Public Elementary Schools to whom the Superannuation Scheme framed in pursuance of Section 70 of the Education Act, Northern Ireland, 1923, applies.

Unclaimed Proceeds of Stamps Sales.

MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND AND BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE UNDER THE NATIONAL HEALTH INSURANCE ACT, 1924.

The Ministry of Labour for Northern Ireland in exercise of the powers conferred on them by Section 68 (2) of the National Health Insurance Act, 1924, and the National Health Insurance

Joint Committee and the said Ministry of Labour acting jointly in exercise of the powers conferred on them by the proviso to the said Section, and of all other powers enabling them in that behalf hereby make the following regulations :—

1.—(1) These Regulations may be cited as the National Health Insurance (Unclaimed Proceeds of Stamp Sales) Regulations (Northern Ireland), 1925.

(2) In these Regulations :—

“ The Act ” means the National Health Insurance Act, 1924 (14 & 15 Geo. 5, c. 38).

“ The Ministry ” means the Ministry of Labour for Northern Ireland.

(3) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

2. The residue of any sums received by the Ministry on account of sales of stamps issued for the purpose of the Act and available for application under Section 68 (2) of the Act shall be applied in manner following :—

For the purpose of assisting approved societies to defray any additional administrative expenses arising from the severance of the system of National Health Insurance in Northern Ireland from that in the Irish Free State there shall be paid out of the said residue (save as in any particular cases the Ministry may otherwise decide) to each approved society whose head office is in Northern Ireland and which had more than twenty insured members resident in Southern Ireland on the 1st day of April, 1922, an amount calculated as follows :—

- (a) where the number of such members of the society did not exceed 1,000, at the rate of 1s. for each of such members, and
- (b) where the number of such members exceeded 1,000, at the rate of 1s. for each of such members up to 1,000 and at the rate of 6d. for each of such members in excess of 1,000.

3. In the case of the sums referred to in the proviso to Section 68 (2) aforesaid as representing contributions paid by or in respect of masters, seamen or apprentices serving on foreign going ships or ships engaged in regular trade on foreign stations the proportion to be credited to the special fund established under Section 64 of the Act shall be 97½ per cent.

4. The National Health Insurance (Unclaimed Proceeds of Stamp Sales) Regulations (Ireland), 1918, (S. R. & O., 1918, No. 1771) in their application to Northern Ireland are hereby revoked.

MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR, ACTING JOINTLY, UNDER THE NATIONAL HEALTH INSURANCE ACT, 1924, AND THE WIDOWS', ORPHANS' AND OLD AGE CONTRIBUTORY PENSIONS ACT (NORTHERN IRELAND), 1925.

The National Health Insurance Joint Committee and the Ministry of Labour, acting jointly, in pursuance of the powers conferred on them by the National Health Insurance Act, 1924, and the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925, and of all other powers enabling them in that behalf, hereby make the following Regulations:—

1.—(1) These Regulations may be cited as the National Health Insurance and Contributory Pensions (Collection of Contributions) Amendment Regulations (Northern Ireland), 1925, and shall be read as one with the National Health Insurance (Collection of Contributions) Regulations (Northern Ireland), 1924 (S.R. & O. of N.I., 1924, No. 87) (hereinafter called "the principal Regulations"), and these Regulations and the principal regulations
