## Workmen's Compensation Valuation.

MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR, ACTING JOINTLY AND IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE PROVISO TO SECTION 25 OF THE WIDOWS', ORPHANS' AND OLD AGE CONTRIBUTORY PENSIONS ACT (NORTHERN IRELAND), 1925.

1926. No. 27.

The National Health Insurance Joint Committee and the Ministry of Labour, acting jointly in pursuance of the powers conferred on them by the proviso to Section 25 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925, the Contributory Pensions (Joint Committee) Regulations (Northern Ireland), 1925, and of all other powers enabling them in that behalf, and in conjunction with the Ministry of Finance, hereby make the following Regulations:—

- 1.—(1) These Regulations may be cited as the Contributory Pensions (Workmen's Compensation Valuation) Regulations (Northern Ireland), 1926, and shall have effect as from the 4th January, 1926.
- (2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.
- 2. For the purposes of the proviso to Section 25 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern

Ireland), 1925, the weekly value of the sum awarded or agreed shall be ascertained by multiplying the amount shown in column 2 of the table set out in the Schedule to these Regulations, appropriate to the age of the child concerned, by the result produced by dividing the number of pounds in the amount awarded, or agreed, by ten:

Provided that any fractional part of sixpence in the sum so ascertained if equal to or greater than half shall be treated as equal to sixpence and any fractional part which is less than half shall be disregarded.

## WILD BIRDS PROTECTION. Taking or Destroying of Eggs.

Made by the Lords Justices of Northern Ireland in pursuance of the Wild Birds Protection Act, 1894, and the Government of Ireland Act, 1920.

1926. No. 51.

Upon application by the County Council of the County of Armagh, we do hereby make the following Order:—

The taking or destroying of the Eggs of the following species of Wild Birds is prohibited throughout the Administrative County of Armagh between the 1st day of June, 1926, and the 1st day of August, 1926, and between the 1st day of March and the 1st day of August in the four subsequent years:—

Buzzard, Chough, Greenfinch, Great-crested Grebe, Harrier, Kingfisher, Peregrine-Falcon, Raven, Siskin, Skylark, Tern (all species), Gull (all species), Owl (all species), Lapwing (Peewit or Green Plover).
