THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND BY VIRTUE AND IN EXERCISE OF THE POWERS VESTED IN IT UNDER THE DISEASES OF ANIMALS ACT, 1894, AS AMENDED AND ADAPTED BY ANY SUBSEQUENT ENACTMENTS, AND OF EVERY OTHER POWER ENABLING IT IN THAT BEHALF, ORDERS AND IT IS HEREBY ORDERED AS FOLLOWS :—

Prohibition of Sale or Exposure or keeping for sale of Fat and Store Swine on the same premises and on the same date.

1. The sale, exposure for sale, or keeping for sale of any store swine at any public sale (as hereinafter defined) in Belfast on any premises on which on the date of such sale, exposure, or keeping, any fat swine is similarly sold, exposed or kept for sale, is hereby prohibited, unless prior to such sale arrangements are made to the satisfaction of the Ministry for the keeping separate of the two classes of swine.

Restrictions on the Re-sale of Store Swine.

2. The sale or exposure for sale at any public sale held in Northern Ireland of any store swine purchased at any public sale held in Belfast within a period of twenty-eight days prior to such sale or exposure is hereby prohibited.

Buyers and Sellers of Swine to give full Information.

3. All persons engaged in buying or selling swine in Belfast shall, so far as is within their knowledge, on request give full information to any authorised officer or to any constable regarding any swine which is or has been in their possession.

Licensing of Premises.

4. The use by swine dealers of any premises in Belfast for the keeping of any swine prior or subsequent to sale or exposure for sale is hereby prohibited unless in accordance with the conditions of a licence issued by the Ministry authorising the using of the premises for such purposes and where such licence is granted the provisions of Article 2 of this Order shall not apply.

Keeping of Records.

5.—(1) All salesmen in Belfast engaged in the business of selling swine shall keep proper written records of their sales (including the names and addresses of buyers and sellers) to the satisfaction of the Ministry or an Authorised Officer and such records shall be open to inspection by an Authorised Officer at all reasonable times.

(2) All persons in Belfast engaged in dealing in swine shall keep similar records of purchases and sales of swine and such records shall likewise be open to inspection as aforesaid.

Production of Licences.

6.—(1) Every person in charge of a pig being kept where, under this Order, a licence is necessary shall on demand of a Justice or of an authorised officer or a member of the Royal Ulster Constabulary produce and show to him the licence, if any, authorising the keeping and shall allow it to be read and a copy of, or extract from, it to be taken by or on behalf of the person to whom it is produced.

(2) Every person so in charge shall on demand as aforesaid give his name and address to the Justice, authorised officer or member of the Royal Ulster Constabulary.

Offences.

7.—(1) If any store swine is sold, or exposed for sale at any public sale held in Belfast in contravention of this Order the person holding the sale and the occupier of the place or premises where the sale is held and the owner or person in charge of each pig exposed thereat and the person conducting the sale and the purchaser thereof of any animal or any other person causing or aiding or abetting such contravention shall each, according to and in respect of his or their own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(2) If any swine is kept on any premises in Belfast in contravention of the provisions of this Order the owner of the premises and the owner of the swine and the person for the time being in charge thereof and the person causing, directing or permitting the keeping as aforesaid shall each according to and in respect of his or their own acts and defaults be deemed guilty of an offence against the Act of 1894.

(3) If any person buying or selling swine in Belfast refuses to give full information or gives false information to an authorised officer or a constable regarding any swine which are, or have been, in his possession such person shall be guilty of an offence against the Act of 1894.

(4) If any person fails to keep such records as the Ministry or an Authorised Officer may direct in pursuance of this Order or makes or keeps false records or refuses to permit such records to be inspected or extracts to be made therefrom by an authorised

officer he shall be deemed guilty of an offence against the Act of 1894.

(5) If any person refuses or neglects to produce and show any licence or refuses to allow same to be read and a copy of or extract from same to be taken as required by this Order or refuses or neglects to give his true name and address as required by this Order he shall be guilty of an offence against the Act of 1894.

Interpretation.

8. Under this Order "Act of 1894" means the Diseases of Animals Act, 1894.

"Authorised" means authorised by the Ministry and "Authorised Officer" includes a Veterinary Inspector.

"Belfast" means the County Borough of Belfast.

"Fat Swine" means a pig deemed by an Inspector of the Ministry to be suitable for immediate slaughter.

"Ministry" means the Ministry of Agriculture for Northern Ireland.

"Person" includes a body corporate.

"Public Sale" includes a market or fair and any sale either by auction or otherwise which is open to the public whether held in a public place or not and whether or not swine of different owners are exposed thereat.

"Store Swine" means a pig deemed by an Inspector of the Ministry to be suitable for further feeding and not suitable for immediate slaughter.

"Swine Fever" has the same meaning as in the Swine Fever (Northern Ireland) Order, 1926.

Other terms have the same meaning as in the Diseases of Animals Act, 1894, and the Acts amending same.

Commencement.

9. This Order shall come into operation on the fifth day of July one thousand nine hundred and twenty-eight.

Short Title.

10. This Order may be cited as the Swine Fever (Belfast) No. 2 Order, 1928.

Revocation.

11. The Swine Fever (Belfast) Order, 1928, is hereby revoked as from the time at which this Order takes effect.

And whereas it appears to the Ministry to be necessary and
proper for the purpose aforesaid to make the adaptations in the
Children Act, 1908, which are hereinafter set forth.

Now, therefore, the Ministry in pursuance and by virtue of
the powers aforesaid and all other powers it thereunto enabling
hereby orders as follows :—

The Children Act, 1908, is hereby adapted in the manner
and to the extent following :—

For and in lieu of sub-section (20) of Section 133 of the said
Children Act, 1908, there shall be and is hereby substituted the
following sub-section :—

For the provisions of this Act relating to the enforcement
of an attendance order there shall be and are hereby sub-
stituted the following provisions :—“ A court of summary
jurisdiction, if satisfied on complaint made by the education
authority that a school attendance order has not been complied
with in the case of a child required by or under the Education
Act (Northern Ireland), 1923, to attend school, shall have the
following powers :—

- (a) In the first case of non-compliance, if the parent of the
child does not appear, or appears and fails to satisfy the

court that he has used all reasonable efforts to enforce compliance with the order, the court may impose a fine not exceeding (including costs) forty shillings ; but if the parent satisfies the court that he has used all reasonable efforts as aforesaid, the court may, without inflicting a fine, order the child to be sent to a certified day industrial school, or if it appears to the court that there is no such school suitable for the child, then to a certified industrial school ; and

- (b) In the second or any subsequent case of non-compliance with the order, the court may order the child to be sent to a certified day industrial school, or if it appears to the court that there is no such school suitable for the child, then to a certified industrial school, and may further in their discretion inflict any such fine as aforesaid, or they may for each such non-compliance inflict any such fine as aforesaid without ordering the child to be sent to an industrial school :
 Provided that—

- (i) a complaint under this sub-section with respect to a continuing non-compliance with a school attendance order shall not be repeated by the education authority at any less interval than two weeks ; and
- (ii) the court in lieu of ordering the child to be sent to an industrial school may make an order for the committal of the child to the care of a relative or other fit person in accordance with the provisions of section fifty-eight of the Children Act, 1908.

‘ Education authority ’ in this section shall have the same meaning as in the Education Act (Northern Ireland), 1923, and references in this Act to a local education authority where they occur in relation to day industrial schools or in relation to children sent to industrial schools at the instance of an education authority or of a local education authority shall be construed as references to an education authority as defined in the Education Act (Northern Ireland), 1923. Other references to a local education authority shall be construed as references to the council of the county or county borough, and any reference to the Elementary Education Act, 1876, or to the Education Acts, 1870 to 1907, or any of those Acts, shall not apply.”

Evening Elementary Schools.

REGULATIONS, DATED 19TH OCTOBER, 1928, MADE BY THE MINISTRY OF EDUCATION FOR NORTHERN IRELAND UNDER SECTIONS 75 AND 77 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923, AND LAID BEFORE BOTH HOUSES OF PARLIAMENT IN PURSUANCE OF SECTION 99 (2) OF THE ACT AFORESAID.

I. *Conditions for the Recognition of Schools.*

1. Grants under these Regulations will be paid only in respect of schools recognised for the purpose by the Ministry.
2. Schools must be under the control of an Education Authority as provided for in the Education Act (Northern Ireland), 1923, or other responsible Manager or body of Managers recognised for the purpose by the Ministry.
3. Applicants for recognition of an evening elementary school must submit to the Ministry a list of the subjects proposed to be taught in the schools under their control, accompanied by a representation from the education authority of the district in which the schools or classes are situated, that the subjects of instruction included in the list are suitable to the circumstances of the education area.
4. The premises in which the schools are conducted must be suitably situated and the accommodation and equipment must be approved by the Ministry.
5. The time-table for each school must receive the approval of the Ministry.
6. Syllabuses of the subjects to be taught must be submitted to the Ministry for approval before the beginning of the session.
7. Any of the subjects provided for in the Programme of Instruction for Public Elementary schools may be taught in evening elementary schools.
