**Slaughtered Animals (Compensation).**

THE SLAUGHTERED ANIMALS (COMPENSATION) ORDER (NORTHERN IRELAND), 1929, DATED 12TH APRIL, 1929.

1929. No. 35.

The Ministry of Agriculture by virtue and in exercise of the power for this purpose vested in it by the Slaughtered Animals (Compensation) Act (Northern Ireland), 1928, and of every other power in that behalf enabling it, hereby appoints the First day of May, One Thousand, nine hundred and twenty-nine, as the day on which the Slaughtered Animals (Compensation) Act (Northern Ireland), 1928, shall come into operation.

**ARMS AND AMMUNITION.****Firearm Permits.**

RULES OF THE MINISTER OF HOME AFFAIRS DATED 22ND MARCH, 1929, FOR CARRYING INTO EFFECT THE FIREARMS ACT, 1920, (10 & 11 GEO. 5, c. 43).

1929. No. 32.

In pursuance of the power conferred on me by Section 15 as read with Section 18 of the Firearms Act, 1920, and by the

General Adaptation of Enactments (Northern Ireland) Order, 1921, under Section 69 of the Government of Ireland Act, 1920, and by the Firearms (Amendment) Act (Northern Ireland), 1926, I hereby make the following rules and prescribe as follows :—

1. If a Firearms Certificate or a Permit has been lost or destroyed, or from other cause its production is impossible, the holder may make application to the Chief Officer of Police for the district in which such Certificate or Permit was originally granted and such Officer on being satisfied as to such loss, destruction or cause, rendering impossible the production of such Certificate or Permit may issue to such applicant a duplicate which for the purposes of the Act shall be treated as the original Certificate or Permit as the case may be, and immediately upon the issue of such duplicate the original Certificate shall thereupon become inoperative. The fee for such duplicate Certificate shall be 1/- and for duplicate Permit 6d.

Either the original Certificate or Permit or the duplicate thereof must be produced when renewal is sought.

If after the issue of a duplicate Certificate or Permit the original Certificate or Permit is found it should be immediately returned to the authority by whom issued.

2. Any duplicate Firearm Certificate or Permit so issued shall require renewal on the same date and in the same manner as the original Certificate.

3. The fee for the issue of a duplicate Certificate or Permit shall be in addition to and not in substitution for any fee which may be payable under the First Schedule to the Firearms Act, 1920, or under Section 1 (4) of the Firearms (Amendment) Act (Northern Ireland), 1926.
