"When the amount fixed as the normal balance exceeds the sum of £50, an account in the name of the Guardians shall be opened with the Treasurer and the Clerk shall lodge the paying order to be drawn by him as aforesaid to the credit of the account. As soon as the account has been opened the Clerk shall lodge to the credit of the account any monies which he has in hands for the purpose of making payments in respect of petty disbursements as aforesaid. Authority shall be given to the Clerk to draw on this account by cheque whenever he requires money for the purpose of making any payments in respect of petty disbursements as aforesaid."

(2) This Order may be cited as the Union Accounts Order, 1930, and shall be construed as one with the Union Accounts Order, 1905.

The Ministry of Agriculture by virtue and in exercise of the powers for this purpose vested in it by the Marketing of Potatoes Act (Northern Ireland), 1928, and of every other power in that behalf enabling it, hereby makes the Rules following, that is to say:—

I. Short Title.

These Rules shall be known as "The Marketing of Potatoes Rules (Northern Ireland), 1930, No. 2."

## II. Prescribed Months.

Article IV of the Marketing of Potatoes Rules (Northern Ireland), 1929, is hereby revoked and the following Article is substituted therefor:—

# Prescribed Months.

The provisions of the Act shall not apply to potatoes sentfrom Northern Ireland during the months of June, July, Augustand September or during such period as may subsequently be prescribed.

#### III. Commencement.

These Rules shall come into operation on the First day of October, 1930.
