

**DRAINAGE.****Appointed Day.**

APPOINTED DAY FOR TRANSFER OF CERTAIN POWERS AND DUTIES  
OF THE MINISTRY OF FINANCE UNDER PART I OF THE  
DRAINAGE ACT (NORTHERN IRELAND), 1929.

WHEREAS it is provided by sub-section (1) of section one of the Drainage Act (Northern Ireland), 1929, that the Ministry of Finance shall, subject to the provisions of the said Act, be the drainage authority for reducing flooding on Lough Neagh and the River Bann in accordance with certain recommendations mentioned in the said sub-section, and that the provisions of paragraphs (a), (b), (d) and (e) of the said sub-section shall have effect as from such day or days as may be respectively appointed by the said Ministry for the purpose of each such provision :

And whereas the first day of May, nineteen hundred and thirty was appointed as the day for the purposes of the provisions of the said paragraphs, except provisions with respect to the Lough Neagh Drainage Trustees :

Now therefore the said Ministry hereby appoints the first day of November, nineteen hundred and thirty-one, as the day for the purposes of the said provisions so far as they relate to the Lough Neagh Drainage Trustees.

REGULATIONS, DATED 31ST AUGUST, 1931, MADE BY THE MINISTRY OF AGRICULTURE, NORTHERN IRELAND, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE, UNDER THE PROVISIONS OF SECTION 99 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923 (13 AND 14 GEO. 5, CH. 21), AS APPLIED BY THE ORDER, DATED 29TH DAY OF MAY, 1925, OF THE GOVERNOR OF NORTHERN IRELAND IN COUNCIL AND LAID BEFORE PARLIAMENT IN ACCORDANCE WITH THE SAID PROVISIONS.

1. These Regulations may be cited as the "Regulations for Agricultural Teachers, 1925, Amending Regulations No. 2, 1931."

2. From and after the date on which these Regulations shall come into operation and effect and until the same shall be in due manner altered or revoked, the incremental portion of the salary of every teacher to whom the Regulations for Agricultural Teachers Northern Ireland, 1925 (hereinafter called the "Principal Regulations") apply shall be reduced by an amount equal to the maximum annual increment awarded to him, in accordance with the Principal Regulations.

3. These Regulations shall take and have effect on and after the 1st December, 1931, and shall thenceforth be construed with and as forming part of the Principal Regulations and the said
