“ the Act of 1924 ” means the National Health Insurance Act, 1924, as it applies in Northern Ireland :

“ the Act of 1925 ” means the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925 :

“ the Medical Benefit Account ” means the Medical Benefit Account established under section ten of the National Health Insurance Act (Northern Ireland), 1930 :

“ the Central Fund ” means the Central Fund established under section sixty-seven of the Act of 1924 :

“ the Pensions Account ” means the Pensions Account (Northern Ireland), established under section eleven of the Act of 1925.

(3) This Order and the Acts shall be construed together, and any reference in any Act or other document to the National Health Insurance Acts (Northern Ireland), 1924 to 1931, or to the enactments relating to national health insurance in Northern Ireland, shall be deemed to include a reference to this Order.

### **Insurance Practitioners' and Pharmaceutical Committees.**

REGULATIONS, DATED 17TH OCTOBER, 1931, MADE BY THE  
MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER  
THE NATIONAL HEALTH INSURANCE ACTS (NORTHERN  
IRELAND), 1924 TO 1931.

1931. No. 127.

The Ministry of Labour for Northern Ireland in exercise of the powers conferred on it by Section 52 and Section 53 of the National Health Insurance Act, 1924, as amended and applied by the National Health Insurance Act (Northern Ireland), 1930, and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

1. These Regulations may be cited as the National Health Insurance (Insurance Practitioners' and Pharmaceutical Committees) Amendment Regulations (Northern Ireland), 1931, and shall be read as one with the National Health Insurance (Insurance Practitioners' and Pharmaceutical Committees) Regulations (Northern Ireland), 1930, hereinafter referred to as "the Principal Regulations."

2. The following Article shall be substituted for Article 13 of the Principal Regulations :—

"13. Members of the Committees appointed under Part 2, Part 3 or Part 4 of these Regulations shall, subject to the provisions of Article 14, hold office for a period of three years from the first day of October in the year of their appointment :

Provided that a person being, on 29th day of September, 1931, a member of a Committee shall, subject to the provisions of Article 14, continue to hold office until 30th September, 1933."

3. These Regulations shall be deemed to have had effect from the 29th day of September, 1931.

The Ministry of Labour for Northern Ireland in exercise of the powers conferred on it by the National Health Insurance Acts (Northern Ireland), 1924 to 1931, and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

1. These Regulations may be cited as the National Health Insurance (Medical Benefit Council) (Amendment) Regulations (Northern Ireland), 1931, and shall be read as one with the National Health Insurance (Medical Benefit Council) Regulations, 1930, hereinafter referred to as the Principal Regulations.
