

“ the Principal Regulations ”), shall until further notice be subject to a reduction of three per cent. of their amount up to and including the first six hundred pounds and to a further reduction of eight per cent. of any amount thereafter.

3. Regulation 8 of the Principal Regulations is hereby repealed and the following Regulation substituted therefor:—

“ There must be enrolled at the school at least such number of pupils between the ages of 6 and 19 as the Ministry considers sufficient to warrant recognition.”

4. The following paragraph is hereby added to Regulation 31 of the Principal Regulations:—

“ (c) There must be sent to the Ministry at such dates as may be prescribed such attendance books, lists, and other information as may be required by the Ministry.”

5. Paragraph (3) of Regulation 32 of the Principal Regulations is hereby repealed and the following substituted therefor:—

“ (3) has made at least 130 attendances at the school, not more than 5 of which have been made in any one week : Provided that the Ministry may pay the grant in respect of a pupil who has made less than 130 attendances—

(i) where the pupil has been appointed by the Ministry as a senior pupil teacher in connection with a public elementary school ; and

(ii) in the case of an epidemic or other serious difficulty affecting the school as a whole.”

6. These Regulations shall take and have effect on and after 1st August, 1931, and shall thenceforth be construed with and as forming part of the Principal Regulations.

Secondary Teachers : Regulations.

REGULATIONS, DATED 22ND MAY, 1931, MADE BY THE MINISTRY OF EDUCATION FOR NORTHERN IRELAND, UNDER SECTIONS 65, 69 AND 77 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923 (13 & 14 GEO. 5, CH. 21), AFTER CONSULTATION WITH THE MINISTRY OF FINANCE AND LAID BEFORE PARLIAMENT IN ACCORDANCE WITH THE PROVISIONS OF SECTION 99 (2) OF THE ACT AFORESAID.

1. These Regulations may be cited as the “ Regulations for Secondary Teachers, 1929, Amending Regulations, No. 2, 1931.”

2. From and after the date on which these Regulations shall come into operation and effect and until the same shall be in due manner altered or revoked, the incremental portion of the salary of every teacher to whom the Regulations for Secondary Teachers Northern Ireland, 1929 (hereinafter called "The Principal Regulations"), apply shall be reduced by an amount equal to the maximum annual increment awarded to him, in accordance with the Principal Regulations.

3. The minimum rates of remuneration of part-time teachers shall be—

Men	5/- per hour.
Women	4/6 „ „

4. These Regulations shall take and have effect on and after 1st August, 1931, and shall thenceforth be construed with and as forming part of the Principal Regulations, and the said Principal Regulations are hereby amended to the extent necessary to give effect to the foregoing provisions.

Technical Schools.

REGULATIONS, DATED 1ST JULY, 1931, MADE BY THE MINISTRY OF EDUCATION FOR NORTHERN IRELAND, UNDER SECTION 99 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923, AND LAID BEFORE PARLIAMENT IN ACCORDANCE WITH THAT SECTION.

1931. No. 77.

1. These Regulations may be cited as "The Technical School Examinations Regulations."

I.—TECHNICAL SCHOOL EXAMINATIONS.

2. Examinations will be held annually by the Ministry of Education (hereinafter referred to as "The Ministry") on the syllabuses of instruction laid down in the "Syllabuses of Technical School Examinations" (hereinafter called the "Examinations Syllabuses") issued from time to time by the Ministry:

Provided that the Ministry may decline to hold an examination in any syllabus of a subject for which a satisfactory number of candidates has not been entered.

3. The Ministry may, at its discretion, require a candidate to attend at his own expense for examination at some centre other than that from which the entry was made.

4. The examinations on the syllabuses of the first and second years of the course in Domestic Economy will be entirely practical and will be conducted in the manner set forth in the First Schedule to these Regulations.
