#### IV. *Commencement.*

These Rules shall come into operation on the thirtieth day of May, nineteen hundred and thirty-two.

#### V. *General.*

The Ministry may from time to time rescind, amend or vary these Rules or any of them as the occasion may require.

DANGEROUS DRUGS AMENDMENT REGULATIONS (NORTHERN IRELAND), 1932, DATED 11TH NOVEMBER, 1932, MADE BY THE MINISTER OF HOME AFFAIRS FOR NORTHERN IRELAND UNDER SECTION 7 OF THE DANGEROUS DRUGS ACT, 1920 (10 & 11 GEO. 5. C. 46) AMENDING THE LIST OF PREPARATIONS IN THE THIRD SCHEDULE TO THE DANGEROUS DRUGS (CONSOLIDATION) REGULATIONS, 1928. (PREPARATIONS EXEMPTED FROM THE REGULATIONS).

I, The Right Honourable Sir Richard Dawson Bates, Minister of Home Affairs for Northern Ireland, in pursuance of Section 7 of the Dangerous Drugs Act, 1920, and of all other powers me thereunto enabling hereby make the following Regulations amending the Dangerous Drugs (Consolidation) Regulations, 1928 (*a*), as applied by the Dangerous Drugs Regulations (Northern Ireland), 1929 (*b*), (hereinafter referred to as the Principal Regulations):—

1. The list of preparations in the Schedule to these Regulations shall be substituted for the list of preparations in the Third Schedule to the Principal Regulations.

2. The Dangerous Drugs (Consolidation) Amendment Regulations (Northern Ireland), 1931 (c), dated the 27th day of April, 1931, are hereby repealed.

3. Copies of the Dangerous Drugs (Consolidation) Regulations, 1928, as applied as aforesaid, printed under the authority of His Majesty's Stationery Office may be printed with the substitution directed to be made by these Regulations.

4. These Regulations may be cited as the Dangerous Drugs Amendment Regulations (Northern Ireland), 1932.

### Black Scab in Potatoes.

BLACK SCAB IN POTATOES (NORTHERN IRELAND) ORDER OF 1932,  
DATED 11TH DAY OF JANUARY, 1932.

1932. No. 4.

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers vested in it under the Destructive Insects and Pests Acts, 1877 and 1907 (40 and 41 Vict., ch. 68, and 7 Edw. 7, ch. 4), and of every other power enabling it in that behalf, orders, and it is hereby ordered as follows:—

#### I. *Short Title.*

This Order shall be known as "The Black Scab in Potatoes (Northern Ireland) Order of 1932."

#### II. *Amendment of the Black Scab in Potatoes (Northern Ireland) Consolidation Order of 1930.*

The Black Scab in Potatoes (Northern Ireland) Consolidation Order of 1930 shall be read and have effect as if the following were included in the First Schedule (Scheduled Districts) thereto:

District No. 7 (Bellaghy Area).

A district comprising:—

The townlands of (and all towns and villages included therein) Drumanee Lower, and East Glebe in the Barony of Loughinsholin, in the Administrative County of Londonderry; those portions (and all towns and villages included therein) which lie to the East of the road from Castledawson to Portglenone via Bellaghy and Ballymacombs More of the townlands of Ballydermot (and Intake adjoining), Ballymacombs Beg, Ballymacombs More, Ballyscullion West (and Intake adjoining), Drumanee Upper, Edenreagh, Killyberry, Killyberry Downing, Leitrim (and Intake adjoining), Old Town Deer Park, Old Town Downing, Tamlaghtduff and West
