THE COMPANIES (FEES) ORDER (NORTHERN IRELAND), 1932, MADE BY THE MINISTRY OF COMMERCE UNDER PART III OF THE COMPANIES ACT (NORTHERN IRELAND), 1932 (22 & 23 GEO. 5, c. 7).

## 1932. No. 124.

Whereas by Section 80 of the Companies Act (Northern Ireland), 1932, it is provided that the Registrar of Companies shall, on payment of the prescribed fee, enter in the register certain particulars with respect to every charge created by any Company or existing on property acquired by the Company and requiring registration under Part III of the said Act, and that the register shall be open to inspection by any person on payment of the prescribed fee not exceeding 1s. for each inspection.

And whereas by Section 84 of the said Act it is provided that the said Registrar shall on payment of the prescribed fee enter in the register of charges the fact of an order having been obtained for the appointment of a receiver or manager of the property of a company or of the appointment of such a receiver or manager under power contained in any instrument.

And whereas by Section 335 of the said Act the expression "prescribed" as used in Sections 80 and 84 means prescribed by the Ministry of Commerce.

Now, therefore, the Ministry of Commerce hereby prescribes as follows:—

The Ministry of Commerce for Northern Ireland in pursuance of the powers conferred upon it by the Companies Act (Northern Ireland), 1932 (hereinafter called "the Act"), and of all other powers enabling it in that behalf hereby orders as follows:—

Forms.

1. The forms set out in the Schedule hereto shall be used for the purposes of the Act and the particulars contained therein are hereby prescribed as the particulars required under the Act.

Certified copy of Charter, etc., under Section 299. 2. (i) A certified copy of the Charter, Statutes, or Memorandum and Articles of the Company, or other Instrument constituting or defining the constitution of the Company required to be delivered to the Registrar under Section 299 of the Act in the case of a Company incorporated in Great Britain or in any of His Majesty's dominions outside Northern Ireland or in any place
