THE NATIONAL HEALTH INSURANCE (APPROVED SOCIETIES) AMENDMENT REGULATIONS, 1932, DATED 14TH SEPTEMBER, 1932, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE UNDER THE NATIONAL HEALTH INSURANCE ACTS (NORTHERN IRELAND), 1924 TO 1932.

1932. No. 106.

The National Health Insurance Joint Committee in pursuance of the powers conferred on them by the National Health Insurance Acts (Northern Ireland), 1924 to 1932, and of all other powers enabling them in that behalf, and subject to the approval of the Ministry of Finance for Northern Ireland, hereby make the following Regulations :--

1. These Regulations may be cited as the National Health Insurance (Approved Societies) Amendment Regulations (No. 4), 1932, and shall be read as one with the National Health Insurance (Approved Societies) Regulations, 1930 (S.R. & O. 1930, No. 523) (hereinafter referred to as "the principal Regulations");

2. The following paragraph shall be inserted after paragraph (1) of Article 11 of the principal Regulations :---

(1A) Where contributions in respect of employment in the Irish Free State have been treated in accordance with the provisions of paragraph 16 of the Schedule to the Irish Free State Reciprocal Arrangements Order, 1924, the Minister, in addition to crediting an amount to the Society in accordance with the provisions of the immediately preceding para "graph of these Regulations, may credit out of the Stamps Sold Account the difference between the amount so credited and the amount which would have been credited if the employment had taken place in Northern Ireland. provided that the aggregate of the additional amounts so credited to all Societies shall not exceed the total amount which may be determined by the Minister to be available for the purpose."

3. These Regulations shall be deemed to have had effect as from 7th July, 1930.
