(i) affect the previous operation of that Order, or any thing duly done or suffered thereunder; or

(ii) affect any right, privilege, obligation, or liability acquired, accrued, or incurred thereunder; or

(iii) affect any penalty incurred in respect of any offence committed against that Order; or

(iv) affect any investigation, legal proceeding, or remedy in respect of any such right, privilege, obligation, liability, or penalty as aforesaid; and any such investigation, legal proceeding, or remedy may be instituted, continued or enforced, and any such penalty may be imposed, as if this Order had not been made.

## IV. Commencement.

This Order shall come into operation on the first day of July 1933.

The Black Scab in Potatoes (Northern Ireland) Consolidation Order, 1930, shall be read and have effect as if the following were included in the First Schedule (Scheduled Districts) thereto:—

DISTRICT No. 8 (Glenariff Area).

A District comprising—

The townlands of (and all towns and villages included therein) Baraghilly, Bay (E.D. Ardelinis), Callisnagh (E.D. Ardclinis), Carrivemurphy, Clonreagh, Craignagat, Diskirt, Doory, Drumnacur (E.D. Ardelinis), Falrusklin, Foriff, Glassmullen, Greenaghan, Kilmore, Red Bay, Tamlaght, Toberwine, Warren, all in the Barony of Glenarm Lower in the Administrative County of Antrim.

THE IMPORTATION OF ELM TREES AND CONIFERS (PROHIBITION)
(NORTHERN IRELAND) ORDER, 1933, DATED 14TH
NOVEMBER, 1933.

The Ministry of Agriculture for Northern Ireland, by virtue and in exercise of the powers vested in it under the Destructive Insects and Pests Acts, 1877 and 1907 (40 and 41 Vict., c. 68, and 7 Edw. 7, c. 4), and of every other power enabling it in that behalf, orders, and it is hereby ordered as follows:—

#### Commencement.

1. This Order shall come into operation on the first day of December, nineteen hundred and thirty-three.

Prohibition of Importation of Elm Trees and Certain Conifers.

- 2.—(1) For the prevention of the introduction of diseases and pests injurious to elm trees and forest trees the landing in Northern Ireland is hereby prohibited of:—
  - (a) Any living plant of the genus specified at (1) in the Schedule hereto from any country outside Ireland.
  - (b) Any living plant of any of the genera mentioned at (2) in the Schedule hereto from any country other than Great Britain, the Irish Free State, the Channel Islands, or the Isle of Man.
- (2) In this Article "plant" includes tree and shrub and the roots, layers, cuttings and other parts of a plant, but does not include seed.

# Restriction on Importation of Plants.

3. The certificates prescribed in Article 4 of the Importation of Plants Order (Northern Ireland), 1933, shall, except in the case
