These Regulations may be cited as the Milk (Grade C) (Amendment No. 2) Regulations (Northern Ireland), 1935, and these Regulations, the principal Regulations, the Milk (Grade C) Regulations (Northern Ireland), 1935 (c), and the amending Regulations, shall be construed together and may be cited as the Milk (Grade C) (Amended No. 2) Regulations (Northern Ireland), 1935.

### **Extension of Enactments (National Health Insurance and Contributory Pensions).**

ORDER IN COUNCIL, DATED 5TH AUGUST, 1935, MADE UNDER  
THE NATIONAL HEALTH INSURANCE AND CONTRIBUTORY  
PENSIONS ACT (NORTHERN IRELAND), 1935 (25 & 26  
GEO. 5, c. 14).

BY THE GOVERNOR IN THE PRIVY COUNCIL OF NORTHERN IRELAND.

(Signed) ABERCORN.

WHEREAS by section twenty-three of the National Health Insurance and Contributory Pensions Act, 1935, passed by the Parliament of the United Kingdom (in this Order referred to as "the United Kingdom Act") it is enacted that the United Kingdom Act, so far as it relates to matters with respect to which the Parliament of Northern Ireland has power to make laws,

shall not extend to Northern Ireland unless and until provision to that effect is made either—

- (a) by an Act of the Parliament of Northern Ireland ; or
- (b) by an Order of the Governor of Northern Ireland in Council made in pursuance of such an Act ;

and that, if and when such provision is made, the United Kingdom Act shall extend to Northern Ireland subject to such exceptions and adaptations as may be specified in such Act or Order as aforesaid, and subject also to the provisions of subsection (2) of section twenty-three of the United Kingdom Act :

And whereas it is enacted by section one of the National Health Insurance and Contributory Pensions Act (Northern Ireland), 1935, passed by the Parliament of Northern Ireland (in this Order referred to as "the Northern Ireland Act") that, in an event which has happened, the United Kingdom Act shall (subject as therein mentioned) come into operation in Northern Ireland, as respects matters with respect to which the Parliament of Northern Ireland has power to make laws, on the date or dates which may be declared by the Governor of Northern Ireland in Council to be the date or dates on which the United Kingdom Act comes into operation as respects matters other than the matters aforesaid, and subject to such exceptions and adaptations as may be specified in the Order in Council ; and that an Order in Council made for the purposes aforesaid may make such modifications and adaptations of any enactments relating to national health insurance and widows', orphans' and old age contributory pensions as appear necessary or expedient for the extension of the United Kingdom Act to Northern Ireland :

And whereas the United Kingdom Act will come into operation, as respects matters other than those with respect to which the Parliament of Northern Ireland has power to make laws, on the several dates provided by the said Act :

And whereas it appears necessary and expedient for the extension of the United Kingdom Act to Northern Ireland that the United Kingdom Act in its application to Northern Ireland should be subject to the exceptions and adaptations hereafter in this Order specified :

Now, therefore, I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in pursuance of the provisions of the Northern Ireland Act, and in exercise of all powers enabling me in this behalf, do hereby declare and order as follows :—

1. The dates on which, by virtue of the Northern Ireland Act, the provisions of the United Kingdom Act are to come into operation in Northern Ireland are as follows :—

Any provision expressly specifying a date for its coming into operation with respect to any particular matter or thing shall come into operation in that behalf as from the date so specified ;

Save as aforesaid, the United Kingdom Act shall come into operation as from the passing thereof.

2. The United Kingdom Act in its application to Northern Ireland shall be subject to the following exceptions and adaptations :—

- (a) For references to the Minister there shall be substituted references to the Ministry of Labour for Northern Ireland ;
- (b) The expression “ medical benefit ” means medical benefit as defined by sub-section (3) of section one of the National Health Insurance Act (Northern Ireland), 1930 ;
- (c) References to the Insurance Act shall be construed as references to that Act as it applies in Northern Ireland, and in particular the references in section eight of the United Kingdom Act to sub-section (2) of section ninety-six and sub-section (2) of section ninety-seven of the Insurance Act shall be construed as references to those sub-sections as amended by section two of the National Health Insurance Act (Northern Ireland), 1928 ;
- (d) In sub-section (3) of section eight the words “ in England ” shall be omitted ;
- (e) The following section shall be substituted for section thirteen :—

“ 13.—(1) The accounts of the Northern Ireland National Health Insurance Fund shall be prepared in such form, in such manner and at such times as the Ministry of Finance for Northern Ireland may direct, and the Comptroller and Auditor-General for Northern Ireland shall examine and certify every such account and shall lay copies thereof, together with his report thereon, before both Houses of the Parliament of Northern Ireland.

(2) Sub-section (3) of section sixty-five of the Insurance Act is hereby repealed so far as it applies to the Northern Ireland National Health Insurance Fund.”

- (f) For references to provisions of the Widows', Orphans' and Old Age Contributory Pensions Act, 1925, and of the Widows', Orphans' and Old Age Contributory Pensions Act, 1929, there shall be respectively substituted references to the corresponding provisions of

the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925, and of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1929 :

Provided that the amendment of section thirty-three of the Widows', Orphans' and Old Age Contributory Pensions Act, 1925, which is made by section eighteen of the United Kingdom Act shall not apply ;

- (g) The reference in section seventeen to the Old Age Pensions Acts shall be construed as a reference to the Old Age Pensions Acts (Northern Ireland), 1908 to 1927 ;
- (h) Sub-section (2) of section fifteen and sub-section (2) of section twenty-one shall not apply.

3. This Order may be cited as the National Health Insurance and Contributory Pensions (Enactments) Order (Northern Ireland), 1935.

### Medical Benefit.

REGULATIONS, DATED 28TH MAY, 1935, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE NATIONAL HEALTH INSURANCE ACTS (NORTHERN IRELAND), 1924 TO 1932.

1935. No. 68.

The Ministry of Labour for Northern Ireland, in exercise of the powers conferred on it by the National Health Insurance Acts (Northern Ireland), 1924 to 1932, and of all other powers enabling it in that behalf, hereby makes the following Regulations :

1.—(1) These Regulations may be cited as the National Health Insurance Medical Benefit (Amendment) Regulations (Northern Ireland), 1935, and shall be read as one with the National Health Insurance (Medical Benefit) Regulations (Northern Ireland), 1930, hereinafter referred to as "the principal Regulations."

(2) These Regulations shall be deemed to have had effect as from the thirteenth day of August, one thousand nine hundred and thirty-four.
