- 3. For the purposes of this Order the expression "local authority" means a county or district council or board of guardians or a regional education committee.
- 4. This Order shall not apply to the appointment of Clerks or Assistant Clerks or Accountants or Assistant Accountants of a County Borough.
- 5.—(a) The provisions of this Order shall come into operation on the First day of July, 1935.
- (b) The Ministry may from time to time assent to any departure from the provisions of this Order.
- 6. This Order may be cited as "The Urban District Councils and Borough Councils (Officers Qualifications) Order, 1935."

REGULATIONS MADE BY THE MINISTRY OF HOME AFFAIRS WITH THE APPROVAL OF THE MINISTRY OF FINANCE, IN PURSUANCE OF THE PROVISIONS OF SECTION 3 (3) OF THE MALONE TRAINING SCHOOL ACT (NORTHERN IRELAND), 1926.

The Ministry of Home Affairs, in exercise of the powers vested in it by Section 3 (3) of the Malone Training School Act (Northern Ireland), 1926 (16 & 17 Geo. V, c. 22), and with the approval of the Ministry of Finance, hereby makes the following regulations:

- 1. The contribution payable by the Council of the County or County Borough in accordance with the provisions of sub-section (3) of Section 3 of the above-mentioned statute, towards the expenses of a youthful offender who has been sent to the Reformatory School pursuant to an Order shall, from the first day of April, Nineteen hundred and thirty-five, and until varied by any subsequent Order, be at the rate of 13/3 per week during such time as such youthful offender is detained in the Reformatory School.
- 2. Payment of the contribution as aforesaid shall be in arrear, and shall be made half-yearly by the Council of the County or County Borough in respect of the half-years ending 30th September and 31st March, respectively, and shall be made not later than two months from the date of the claim for payment.

3. The regulations made by the Ministry of Home Affairs and approved by the Ministry of Finance on the 14th day of September, 1934, are hereby revoked.
