Pigs: Additional Licence Fee.

THE PIGS MARKETING (ADDITIONAL LICENCE FEE) REGULATIONS (NORTHERN IRELAND), 1935, DATED 30TH OCTOBER, 1935, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND, UNDER SECTION THREE AND SECTION TWELVE OF THE AGRICULTURAL MARKETING (PIG INDUSTRY) ACT NORTHERN IRELAND), 1934 (25 Geo. 5, Ch. 3).

Whereas it is provided by section three of the Agricultural Marketing (Pig Industry) Act (Northern Ireland), 1934 (hereinafter referred to as "the Act") that the fee for the granting or renewal of a licence under section four of the Agricultural Produce (Meat Regulation) Act (Northern Ireland), 1930, (hereinafter referred to as "the Act of 1930") shall consist of:—

- (a) a sum of ten pounds payable upon the granting or renewal of the licence, or a sum of five pounds so payable, if the licence is limited to the case where the number of carcases examined by an inspector under the Act of 1930 in the period of twelve months to which the licence relates is less than two hundred; and
- (b) an additional sum payable in the prescribed manner and at the prescribed times and calculated at such rate as may be prescribed, but not being in any case a rate higher than sixpence for each carcase examined by an inspector under the Act of 1930:

And whereas it is provided by section twelve of the Act that the Ministry of Agriculture for Northern Ireland (hereinafter referred to as "the Ministry") may make regulations prescribing anything which is to be prescribed:

Now, therefore, the Ministry in exercise of the powers conferred upon it by the said sections of the Act, and of every other power enabling it in that behalf, hereby makes the following Regulations that is to say:—

- 1. There shall be payable by each licensed bacon-curer in addition to the sum of ten pounds or five pounds payable upon the granting or renewal of his licence, a sum calculated at the rate of twopence for each carcase examined by an inspector under the Act of 1930, and such additional sum shall be payable to the Ministry in respect of the month of October, 1935, and of each succeeding month, on or before the tenth day of the following month.
- 2. The Pigs Marketing (Grading Fee) (Northern Ireland) Order, 1934, is hereby revoked.

3. These Regulations may be cited as the Pigs Marketing (Additional Licence Fee) Regulations (Northern Ireland), 1935.

Pigs: Form of Curers' Returns.

THE MARKETING OF PIGS (FORM OF CURERS' RETURNS) (NORTHERN IRELAND) (NO. 1) REGULATIONS, 1935, DATED 28TH JANUARY, 1935, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION TEN AND SECTION TWELVE OF THE AGRICULTURAL MARKETING (PIG INDUSTRY) ACT (NORTHERN IRELAND), 1934 (25 GEO. 5, CH. 3).

Whereas by section ten of the Agricultural Marketing (Pig Industry) Act (Northern Ireland), 1934 (hereinafter referred to as "the Act") it is provided inter alia that every licensed baconcurer shall keep such records and furnish to the Ministry of Agriculture for Northern Ireland (hereinafter referred to as "the Ministry") such returns and other information, in relation to—

- (a) his production of bacon; and
 - (b) his purchases of pigs for curing into bacon, and his sales of bacon (including prices paid and obtained);

as may be prescribed by the Ministry:

And whereas it is provided by section twelve of the Act that the Ministry of Agriculture may make regulations prescribing anything which is to be prescribed:

Now, therefore, the Ministry, in exercise of the powers conferred upon it by the said sections of the Act and of every other power enabling it in that behalf, hereby makes the following regulations,, that is to say:—

Short Title and Commencement.

1. These Regulations may be cited as the Marketing of Pigs (Form of Curers' Returns) (Northern Ireland) (No. 1) Regulations, 1935, and shall come into operation on the date hereof.
