THE INCONSIDERABLE EMPLOYMENTS (PERSONS UNDER SIXTEEN)
(REVOCATION) REGULATIONS (NORTHERN IRELAND), 1935.

1935. No. 83.

The Unemployment Insurance (Inconsiderable Employments) (Persons under Sixteen) (Revocation) Regulations (Northern Ireland), 1935, dated 29th June, 1935, made by the Ministry of Labour for Northern Ireland under the Unemployment Insurance Acts (Northern Ireland), 1920 to 1934.

The Ministry of Labour for Northern Ireland, by virtue of the powers conferred on it by Section 35 of the Unemployment Insurance Act, 1920, and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

1. The Unemployment Insurance (Inconsiderable Employments) (Persons under Sixteen) Regulations (Northern Ireland), 1934, are hereby revoked but without prejudice to any right, privilege, obligation or liability acquired, accrued, or incurred thereunder.

2.—(1) These Regulations may be cited as the Unemployment Insurance (Inconsiderable Employments) (Persons under Sixteen) (Revocation) Regulations (Northern Ireland), 1935, and shall have effect as from the 8th July, 1935.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

Increase of Benefit in respect of Dependent Children.

ORDER IN COUNCIL, DATED 29TH OCTOBER, 1935, MADE UNDER
THE UNEMPLOYMENT ACT (NORTHERN IRELAND), 1934

BY THE GOVERNOR IN THE PRIVY COUNCIL OF NORTHERN IRELAND.

ABERCORN.

WHEREAS by section eighteen of the Unemployment Act (Northern Ireland), 1934, it is provided that in the event of an order being made at any time under Part I of the Unemployment

Act, 1934, passed by the Parliament of the United Kingdom, for the amendment of any provisions of the Unemployment Insurance Acts as applying to Great Britain (hereinafter referred to as a "statutory order"), then in that event there shall apply to Northern Ireland so much as the Governor of Northern Ireland by Order in Council declares applicable of the provisions contained in such statutory order :

And whereas it is further provided in the said section that an Order in Council thereunder may make such adaptations of any provisions contained in any statutory order as appear necessary or expedient for carrying into effect the application of those provisions to Northern Ireland, and that as from any date specified in such Order in Council the Unemployment Insurance Acts as applying in Northern Ireland shall have effect subject to the provisions of the statutory order applied to Northern Ireland by such Order in Council :

And whereas a statutory order has been made for the amendment of section 37 of the Unemployment Insurance Act, 1935, by increasing the amount of the unemployment benefit payable in respect of dependent children :

Now, therefore, I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of St. Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in pursuance of the provisions of the said section eighteen and of all other powers enabling me in that behalf, do hereby declare that so much of the provisions contained in the aforesaid statutory order as provides for such amendment as aforesaid is applicable to Northern Ireland :

And I do hereby order as follows :—

1. For carrying into effect the application of the said provisions to Northern Ireland, Article I of the said Statutory Order shall be adapted to such extent as may be necessary so that the same may be read and have effect as follows :—

Section 4 of the Unemployment Insurance Act (Northern Ireland), 1928 (which provides, among other things, for an increase of benefit in respect of dependent children) shall have effect as if, in sub-section (2) thereof, there were substituted for the words "two shillings" the words "three shillings."

2. The date as from which the Unemployment Insurance Acts as applying in Northern Ireland are to have effect subject to the provisions of the statutory order applied as aforesaid is the 31st day of October, 1935.

3. This Order may be cited as the Unemployment Insurance (Increase of Benefit in respect of Dependent Children) Order (Northern Ireland), 1935.
