

2. Article 19 of the principal Regulations shall be read and have effect as if after the word "benefit" in sub-paragraph (ii) the following words were inserted:—

"and for defraying the cost of other special factors affecting the provision of adequate medical service in rural areas, such further sums out of any amounts carried to the credit of the Medical Benefit Account under proviso (ii) of Article 17 (1) of the Approved Societies Regulations, 1930, as applied to Northern Ireland, as the Ministry may, from time to time, determine."

3. The Third Schedule to the principal Regulations shall be altered in manner following, that is to say:—

(i) After the word "Splints" in the said Schedule the following words shall be added by way of definition:—

"rigid, including Gooch splinting and poroplastic, but excluding walking caliper splints, surgical boots and foot supports worn with boots or shoes."

(ii) There shall be added to the list of appliances contained in the said Schedule the following:—

"Spinal jackets when required for treatment of fractures, dislocations or diseases of the spine."

POISONS.

ORDER IN COUNCIL, DATED 16TH APRIL, 1935, APPROVING RESOLUTION PASSED BY THE PHARMACEUTICAL SOCIETY OF NORTHERN IRELAND AND THE MEDICAL FACULTY OF QUEEN'S UNIVERSITY, BELFAST, AMENDING PART I OF THE FOURTH SCHEDULE TO THE PHARMACY AND POISONS ACT (NORTHERN IRELAND), 1925.

BY THE GOVERNOR IN THE PRIVY COUNCIL OF NORTHERN IRELAND.

WHEREAS by Section one of the Poisons (Ireland) Act, 1870, as that Act applies in Northern Ireland and, in particular, as the same is amended by section twenty-four of the Pharmacy and Poisons Act (Northern Ireland), 1925 (which Act of 1870, as so

applying and amended, is hereinafter referred to as "the Act of 1870"), it is enacted that—

- (a) the several articles mentioned in the Fourth Schedule to the Pharmacy and Poisons Act (Northern Ireland), 1925, shall be deemed to be poisons within the meaning of the Act of 1870,
- (b) the Council of the Pharmaceutical Society of Northern Ireland and the Medical Faculty of the Queen's University of Belfast may, from time to time, by resolution passed both by the said Council and by the said Medical Faculty, declare that any article, other than those mentioned in the said Schedule, and in such resolution named ought to be deemed a poison within the meaning of the Act of 1870,
- (c) thereupon the said Council and Medical Faculty shall submit the said resolution for the approval of the Privy Council of Northern Ireland, and
- (d) if such approval shall be given, then such resolution and approval shall be advertised in the Belfast Gazette, and on the expiration of one month from such advertisement the article named in such resolution shall be deemed to be a poison within the meaning of the Act of 1870 :

And Whereas both the said Council and the said Medical Faculty, by virtue and exercise of the powers vested in them by section one of the Act of 1870, did, on the fifteenth day of February, nineteen hundred and thirty-five, and the twenty-sixth day of February, nineteen hundred and thirty-five, respectively, resolve and declare as follows :—

"That pursuant to Section 1 of the Poisons (Ireland) Act, 1870, as amended by Section 24 (3) of the Pharmacy and Poisons Act (Northern Ireland), 1925, the substances as follows be added to Part 1 of the Fourth Schedule of the Pharmacy and Poisons Act (Northern Ireland), 1925 :—

Dinitro phenols ; dinitro cresols ; preparations or admixtures containing dinitro phenols ; preparations or admixtures containing dinitro cresols.

Phenyleinchroninic acid, its salts, its esters ; derivatives of phenyleinchroninic acid, their salts, their esters ; preparations and admixtures containing phenyleinchroninic acid, its salts, its esters ; preparations and admixtures containing derivatives of phenyleinchroninic acid, their salts, their esters."

And Whereas the above Resolution has been submitted for the approval of the Privy Council of Northern Ireland, and the said

Privy Council are of opinion that the said Resolution should be approved :

Now, therefore, the Privy Council of Northern Ireland are hereby pleased to signify their approval of the said Resolution.

POTATOES, MARKETING OF.

Rules.

THE MARKETING OF POTATOES RULES (NORTHERN IRELAND),
1935, DATED 22ND DAY OF JUNE, 1935.

1935. No. 78.

The Ministry of Agriculture by virtue and in exercise of the powers for this purpose vested in it by the Marketing of Potatoes Acts (Northern Ireland), 1928 and 1934, and of every other power in that behalf enabling it, hereby makes the Rules following, that is to say :—

I. *Short Title.*

These Rules shall be known as the Marketing of Potatoes Rules (Northern Ireland), 1935.

II. *Revocation.*

Article VII of the Marketing of Potatoes Rules (Northern Ireland), 1933, is hereby revoked.

III. *Commencement.*

These Rules shall come into operation on the twenty-sixth day of June, 1935.

In Witness whereof the Official Seal of the Ministry of Agriculture (Northern Ireland) is hereunto affixed this twenty-second day of June nineteen hundred and thirty-five.
