

Local Authorities : Officers' Qualifications.

THE LOCAL AUTHORITIES (ENTERTAINMENTS AND PUBLICITY MANAGERS' QUALIFICATIONS) ORDER, 1936.

1936. No. 26.

To each county borough, borough or urban district in Northern Ireland ; and to all whom it may concern :

The Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry") in exercise of the powers vested in it by section 18 of the Local Government Act (Northern Ireland), 1934, and of every other power in that behalf enabling the Ministry, hereby prescribes with respect to the appointment of Entertainments Managers and of Publicity Managers of local authorities in Northern Ireland, as follows, that is to say :—

1. No person shall be qualified to be appointed to the office of Entertainments Manager of a local authority in Northern Ireland unless he has had adequate experience, and has shown capacity, in the provision, organisation and control of public entertainments and attractions or other undertakings of a like kind.

2. No person shall be qualified to be appointed to the office of Publicity Manager of a local authority in Northern Ireland unless he has had adequate experience, and has shown capacity in the organisation of publicity.

3. No person shall be qualified to be appointed to either of the offices aforesaid unless in addition to the qualifications specified in Articles 1 and 2 hereof—

(a) he produces satisfactory evidence to the Ministry that his health and character are good ;

(b) he is a natural born British subject and the son of a father also a natural born British subject, and has during the whole of the period of five years ending on the date of appointment been resident in the United Kingdom :

4. For the purposes of this Order the expression "local authority" means the Council of a County Borough, Borough or Urban District.

5. —(a) The provisions of this Order shall come into operation on the 19th day of March, 1936.

(b) The Ministry may from time to time assent to any departure from the provisions of this Order.

6. This Order may be cited as "The Local Authorities (Entertainments and Publicity Managers' Qualifications) Order, 1936."

Rural Districts Invested with Urban Powers.

ORDER, DATED THE 15TH DAY OF AUGUST, 1936, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 33 (2) OF THE LOCAL GOVERNMENT (IRELAND) ACT, 1898.

1936. No. 115.

To the Council of each Rural District in Northern Ireland ; and to all others whom it may concern :

WHEREAS it is enacted in effect by section 33 (2) of the Local Government (Ireland) Act, 1898, that rural district councils shall have such powers and duties of urban sanitary authorities under the Public Health Acts or any other Act and such provisions of any of those Acts relating to urban districts shall apply to rural districts as the Ministry of Home Affairs for Northern Ireland may by general order direct and that every such order shall be forthwith laid before Parliament :

Now, therefore, the Ministry of Home Affairs for Northern Ireland in pursuance of the powers vested in it by section 33 (2) of the Local Government (Ireland) Act, 1898, and by all other statutes in that behalf enabling the Ministry hereby orders and directs as follows, that is to say :—

Every rural district council in Northern Ireland shall have the powers and duties of an urban sanitary authority under the provisions of section 80 of the Public Health (Ireland) Act, 1878, which relates to the lighting of urban districts, and accordingly such section is hereby declared to be in force and to apply in every rural district in Northern Ireland.
