#### EDUCATION

13. Clauses (a) and (b) of Article 133 of the Principal Regulations are hereby repealed and the following clauses substituted therefor :—

133.—(a) A convent school or a school conducted by the Christian Brothers shall, subject to the provisions of clause (b) of this Article, receive grants on a capitation system.

(b) In any convent school or school conducted by the Christian Brothers in which every member of the teaching staff either possesses the qualifications prescribed for the teachers of ordinary public elementary schools or is eligible for recognition in his or her position in the school under the terms of Article 66 (e), the teachers thereof shall, if the conductors so elect, be paid at the same rates as teachers of ordinary public elementary schools, and in such case section (a) hereof shall not apply.

14. Article 134 of the Principal Regulations is hereby repealed.

15. These Regulations shall be construed with and as forming part of the Principal Regulations.

16. These Regulations may be cited as the Public Elementary Schools Regulations, 1934, Amending Regulations, No. 3, 1936.

# Secondary Schools : Examinations.

REGULATIONS, DATED THE 21ST DAY OF APRIL, 1936, MADE BY THE MINISTRY OF EDUCATION FOR NORTHERN IRELAND, UNDER SECTION 99 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923, AND LAID BEFORE PARLIAMENT IN ACCORDANCE WITH THE PROVISIONS OF THAT SECTION.

#### 1936. No. 48.

The Secondary School Examinations Regulations, 1935-Statutory Rules and Orders of Northern Ireland, 1935, No. 45-(hereinafter called the "Principal Regulations") are hereby amended as follows :---

1. These Regulations may be cited as "The Secondary School Examinations Regulations, Amending Regulations, No. 1."

## Secondary Schools : Examinations

"In the Junior Certificate Examination,

in Music a candidate may not pass with credit or distinction who has not satisfied the Ministry in the practical test;"

3. Regulation 11 of the Principal Regulations is hereby repealed and the following Regulation is substituted therefor :----

"11.—(a) Every such form of entry must reach the Ministry not later than 31st January in the year in which the examination is to be held and must be accompanied by the prescribed fee in respect of each candidate whose name appears thereon.

(b) The prescribed fee in respect of each candidate entered for the Junior or Senior Certificate shall be twelve shillings and six pence, together with an additional fee of five shillings in respect of each candidate entered for Music : provided that a candidate who is entered for and has paid the fee prescribed for the King's Scholarship Examination in the same year shall if entered also for the Senior Certificate be exempt from the fee of twelve shillings and six pence for the latter."

4. Regulation 15 of the Principal Regulations is hereby repealed and the following Regulation is substituted therefor :—

"15.—(a) Every application from an extern student must be accompanied by the prescribed fee.

(b) The prescribed fee in respect of each extern student shall be, for either the Junior or Senior Certificate Examination :---

Seven shillings and sixpence for each subject or an inclusive fee of one guinea and a half for any number of subjects whichever is the less, together with an additional fee of five shillings for Music :

Provided that a student who is an entrant for and has paid the fee prescribed for the King's Scholarship Examination in the same year shall be required to pay an additional fee of five shillings if entered for Music in the Certificate Examinations, but shall not be required to pay any further fee in respect of the subjects taken as part of the King's Scholarship Examination."

5. Regulation 20 in the Principal Regulations is hereby amended by the addition of the following after sub-section (5) (b) (V):—

(VI). Music.

#### EDUCATION

6. Regulation 32 of the Principal Regulations is hereby repealed and the following substituted therefor :---

"The Ministry will award Junior Exhibitions to those successful candidates who have obtained the highest aggregates of marks in English and those seven other subjects of the examination in which they have gained most marks."

7. These regulations shall come into operation and have effect as from 1st August, 1936, after which date they shall be read with and as forming part of the Principal Regulations.

# Secondary Schools : Grants.

REGULATIONS DATED 24TH NOVEMBER 1936 MADE BY THE MINISTRY OF EDUCATION, NORTHERN IRELAND, UNDER SECTION 77 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923, AND DULY LAID BEFORE PARLIAMENT.

## 1936. No. 169.

The Secondary School Grants Regulations, Northern Ireland, 1935—Statutory Rules and Orders of Northern Ireland, 1935, No. 76 (hereinafter called the Principal Regulations) are hereby amended as follows :—

1. Regulation 35 of the Principal Regulations shall, save as respects the payment of grants, payable as therein, for the school year ending 31st July, 1936, cease to have effect, and the following Regulation shall be substituted therefor :---

"35. The grants payable to a school under Regulations 33 and 34 hereof, in respect of attendances made by pupils from and after 1st August, 1936, shall be subject to a reduction of five per cent. of any amount exceeding six hundred pounds sterling."

2. These Regulations may be cited as "The Secondary School Grants Regulations, Northern Ireland, 1935, Amending Regulations, No. 1, 1936."
