

the Second Schedule to the National Health Insurance Act (Northern Ireland), 1930, and of all other powers enabling them in that behalf and in conjunction with the Ministry of Finance, hereby make the following Regulations :—

1. These Regulations may be cited as the Contributory Pensions (Exempt and Excepted Persons) Amendment Regulations (Northern Ireland), 1936, and shall be read as one with the Contributory Pensions (Exempt and Excepted Persons) Consolidated Regulations (Northern Ireland), 1932 (hereinafter referred to as the "Principal Regulations").

2. The following paragraph shall be added and shall be deemed always to have been added to Article 3 of the Principal Regulations :—

"A person, who on attaining the age of 65 is deemed to be an insured person by virtue of the provisions of Section 14 (2) of the Pensions Act, or is deemed to continue to be so insured by virtue of the foregoing provisions of this Article shall be deemed so to continue throughout his life."

Full Time Instruction.

REGULATIONS, DATED 22ND APRIL, 1936, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE IN CONJUNCTION WITH THE MINISTRY OF FINANCE UNDER THE WIDOWS', ORPHANS' AND OLD AGE CONTRIBUTORY PENSIONS ACTS (NORTHERN IRELAND), 1925 TO 1935.

The National Health Insurance Joint Committee in conjunction with the Ministry of Finance for Northern Ireland in exercise of the powers conferred on them by section 30 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925, and of all other powers enabling them in that behalf, hereby make the following Regulations :—

1.—(i) These Regulations may be cited as the Contributory Pensions (Full Time Instruction) Regulations (Northern Ireland), 1936, and shall be deemed to have had effect from 2nd August, 1935.

(ii) The Interpretation Act, 1921, applies to these Regulations as it applies to an Act of Parliament.

2. For the purposes of section 16 of the National Health Insurance and Contributory Pensions Act, 1935, as extended to Northern Ireland by the National Health Insurance and Contributory Pensions Act (Northern Ireland), 1935, and the National Health Insurance and Contributory Pensions (Enactments) Order (Northern Ireland), 1935, a child shall be deemed to be under full time instruction in a day school during any period during which he would have been under such instruction, but for the occurrence of any of the following events :—

- (i) holidays of the child which are recognised by the responsible school authority ;
- (ii) the closing, by reason of infectious disease, of the school which the child normally attends ;
- (iii) absence from school of the child authorised by the responsible school authority by reason of contact with infectious disease ;
- (iv) illness of the child, so however that any period of illness after the date on which the child attains the age (not being less than 14 years) at which under the law for the time being in force his parent or guardian ceases to be under an obligation to cause him to attend school, shall not be deemed to be a period of full time instruction unless the child attends school at some time between that date and the 31st July next following the 16th birthday of the child ;
- (v) the temporary suspension of the ordinary means of transport of the child to school where alternative means of reaching school are not reasonably available ;
- (vi) absence from school on not more than one occasion in any calendar year owing to the removal of the child from one school to another, so however that any such absence after the first four weeks shall not be deemed to be a period of full time instruction ;
- (vii) absence from school on not more than two occasions in any calendar year owing to illness occurring at, or any absence from school owing to death at, the home of the child, so however that any such absence after the first two weeks shall not be deemed to be a period of full time instruction.

Great Britain Reciprocal Arrangements.

REGULATIONS, DATED 18TH JUNE, 1936, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND, IN CONJUNCTION WITH THE MINISTRY OF FINANCE FOR NORTHERN IRELAND, UNDER SECTION 33 OF THE WIDOWS', ORPHANS' AND OLD AGE CONTRIBUTORY PENSIONS ACT (NORTHERN IRELAND), 1925.(a).

The Ministry of Labour for Northern Ireland, in conjunction with the Ministry of Finance for Northern Ireland, in exercise of the powers conferred on them by Section 33 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1925, and of all other powers enabling them in that behalf, hereby make the following Regulations:—

1—(1.) These Regulations may be cited as the Contributory Pensions (Great Britain Reciprocal Arrangements) Regulations (Northern Ireland), 1936, and shall be deemed to have had effect as from the 1st January, 1935.

(2) Words and expressions in these Regulations shall have the same meaning as in the Memorandum of Arrangements set out in the Schedule to these Regulations.

2. The provisions contained in the Memorandum of Reciprocal Arrangements set out in the Schedule to these Regulations shall have full force and effect so far as the same relate to Northern Ireland and the Acts shall have effect in Northern Ireland subject to such modifications and adaptations as may be required in the Acts for the purpose of giving effect to the provisions contained in the said Memorandum.
