Now, therefore, the Ministry of Home Affairs for Northern Ireland in exercise of the powers conferred on the Ministry by Section 22 of the Finance Act, 1921, as amended by section 5 of the Finance Act (Northern Ireland), 1937, and of all other powers in this behalf enabling the said Ministry hereby orders as follows:—

1. Notwithstanding anything contained in any order to the contrary the periods of the year for which licences under the Finance Act, 1920, in respect of mechanically propelled vehicles may be taken out shall in the case of mechanically propelled vehicles to which Section 5 of the Finance Act (Northern Ireland), 1937, applies include the following periods, that is to say:—

A licence may be taken out for seven consecutive days at any of the following holiday periods in each year:—Christmas, Easter, Whitsun and 12th July, and the duty payable upon such licences shall be one-fifty-second of the full annual rate of duty and a further amount calculated at the rate of ten per cent. upon the amount so ascertained as aforesaid, a resultant fraction of a penny being reckoned as one penny.

2. This Order may be cited as "The Road Vehicles (Part Year Licensing) (Northern Ireland) Order, 1937."

The Interpretation Act, 1889, as applied to Northern Ireland by the Interpretation Act, 1921, shall apply for the purposes of this Order as it applies for the purposes of the interpretation of an Act of Parliament.

SPECIAL ORDER, DATED SEPTEMBER 6, 1937, \*MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR FOR NORTHERN IRELAND, ACTING JOINTLY UNDER PARAGRAPH (d) OF PART I OF THE FIRST SCHEDULE TO THE NATIONAL HEALTH INSURANCE ACT, 1936 (26 GEO. 5 & 1 EDW. 8, c. 32).

The National Health Insurance Joint Committee and the Ministry of Labour for Northern Ireland, acting jointly, in pursuance of the powers conferred on them by paragraph (d) of Part I of the First Schedule to the National Health Insurance Act, 1936 (hereinafter referred to as "the Act"), and of all other powers enabling them in that behalf, hereby make the following Order:—

- 1.—(1) This Order may be cited as the National Health Insurance (Employment under Local and Public Authorities) Order (Northern Ireland), 1937.
- (2) In this Order the expression "office" includes any office, situation, or employment and the expression "pensionable office" means an office coming within the provisions of any Act authorising the grant of a superannuation allowance. In relation to employment the expression "permanent capacity" does not include any employment in which the employed person is liable to dismissal at less than one month's notice.
- (3) The Interpretation Act, 1921, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.
- 2. Employment of any class specified in the Schedule to this Order shall be deemed not to be employment within the meaning of the Act.
- 3. The National Health Insurance (Employment under Local and Public Authorities) Order (Northern Ireland), 1925 (S.R. & O. of N.I., 1925, No. 125), is hereby revoked, but without prejudice to any right, privilege, obligation or liability acquired, accrued or incurred thereunder.

## SCHEDULE.

Employment under any Local or other Public Authority:-

- (a) In any pensionable office in a permanent capacity;
- (b) As chaplain or other minister of religion;
- (c) As duly-qualified medical practitioner;
- (d) As coroner or deputy coroner;
- (e) . As public analyst;
- (f) As public vaccinator;
- (g) As registrar, assistant registrar, superintendent registrar or assistant superintendent registrar of births and deaths, or as registrar, deputy registrar, superintendent registrar or deputy superintendent registrar of marriages;
- (h) Under a contract of apprenticeship without money payment;
- (i) Otherwise than within the meaning of Part I (a), (b), (c), (e) or (f) of the First Schedule to the Act, in the execution of contracts not requiring personal service on the part of the employed person;
- (j) As a contractor with the Authority for the construction, maintenance, improvement, or repair of roads or other public works, unless he is mainly dependent for his livelihood on his earnings from such employment, or the employment is under a contract of service.

Employment under a Board of Guardians:-

(a) As a pauper;(b) In rearing boarded-out pauper children.

Employment as a pilot under the Londonderry Port and Harbour Commissioners.
