

Employment under Local and Public Authorities.

THE UNEMPLOYMENT INSURANCE (EMPLOYMENT UNDER LOCAL AND PUBLIC AUTHORITIES) REGULATIONS (NORTHERN IRELAND), 1937, DATED NOVEMBER 22ND, 1937, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936 (26 GEO. 5 & 1 EDW. 8, CH. 30).

The Ministry of Labour for Northern Ireland, in pursuance of the powers conferred on it by paragraph 3 of Part I. of the First Schedule to the Unemployment Insurance Act (Northern Ireland), 1936 (hereinafter referred to as "the Act") and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Unemployment Insurance (Employment under Local and Public Authorities) Regulations (Northern Ireland), 1937.

(2) In these Regulations the expression "office" includes any office, situation or employment, and the expression "pensionable office" means an office coming within the provisions of any Act authorising the grant of a superannuation allowance. In relation to employment the expression "permanent capacity" does not include any employment in which the employed person is liable to dismissal at less than one month's notice.

(3) The Interpretation Act, 1921, applies to the interpretation of these Regulations, as it applies to the interpretation of an Act of Parliament.

2. There shall be excluded from the employments that are employments within the meaning of the Act the employments set out in the Schedule hereto.

3. The Unemployment Insurance (Employment under Local and Public Authorities) Order (Northern Ireland), 1925 (No. 2), (S. R. & O. of Northern Ireland, 1925, No. 127), is hereby revoked but without prejudice to anything duly done or suffered or to any right, privilege, obligation, or liability acquired, accrued, or incurred thereunder.

SCHEDULE.

Employment under any Local or other Public Authority :—

- (a) In any pensionable office in a permanent capacity ;
- (b) As chaplain or other minister of religion ;
- (c) As duly qualified medical practitioner ;
- (d) As coroner or deputy coroner ;
- (e) As public analyst ;
- (f) As public vaccinator ;
- (g) As registrar, assistant registrar, superintendent registrar or assistant superintendent registrar of births and deaths, or as registrar, deputy registrar, superintendent registrar or deputy superintendent registrar of marriages ;
- (h) Under a contract of apprenticeship without money payment ;

- (e) Otherwise than within the meaning of paragraphs 1 and 2 of Part I. of the First Schedule to the Act, in the execution of contracts not requiring personal service on the part of the employed person ;
- (f) As a contractor with the authority for the construction, maintenance, improvement, or repair of roads or other public works, unless he is mainly dependent for his livelihood on his earnings from such employment, or the employment is under a contract of service.

Employment under a Board of Guardians :—

- (a) As a pauper ;
- (b) In rearing boarded-out pauper children.

Employment as a pilot under the Londonderry Port and Harbour Commissioners.

Inconsiderable Employments.

THE UNEMPLOYMENT INSURANCE (INCONSIDERABLE EMPLOYMENTS) REGULATIONS (NORTHERN IRELAND), 1937, DATED THE 22ND DAY OF SEPTEMBER, 1937, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER SECTION 3 OF THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936.

The Ministry of Labour for Northern Ireland, by virtue of the powers conferred on it by Section 3 of the Unemployment Insurance Act (Northern Ireland), 1936, and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

1. There shall be added to the excepted employments the classes of employment specified in the first column of the Schedule hereto, subject to the conditions and exceptions and only as respects the persons who are employed to the extent specified in the second column of the said Schedule.

2. In these Regulations the expression “ week ” means the period of 7 days commencing at midnight between Sunday and Monday.

3.—(1) These Regulations may be cited as the Unemployment Insurance (Inconsiderable Employments) Regulations (Northern Ireland), 1937, and shall come into force on the date hereof.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

(3) The Unemployment Insurance (Inconsiderable Employments) Regulations (Northern Ireland), 1936(a) and the Un-
