# Insurance Industry Special Scheme.

THE UNEMPLOYMENT INSURANCE (INSURANCE INDUSTRY SPECIAL SCHEME) (VARIATION AND AMENDMENT) ORDER (NORTHERN IRFLAND), 1937, DATED 3RD APRIL, 1937, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936 (26 GEO. 5, AND 1 EDW. 8, CHAP. 30).

# 1937. No. 34.

WHEREAS the Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry") by the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1936, approved for the purposes of Section 18 of the Unemployment Insurance Act, 1920, a Special Scheme for the Insurance Industry, and varied and amended the said Scheme, which Scheme as so varied and amended is hereinafter referred to as "the Scheme";

And whereas it is provided by sub-section (6) of Section 77 of the Unemployment Insurance Act (Northern Ireland), 1936 (hereinafter referred to as "the Act") that for the purpose of securing in the case of a Special Scheme that like rates of benefit shall be payable to the persons to whom the Scheme applies as are for the time being payable under the general provisions of the Act, or any amendment thereof, and that the benefits under the scheme shall otherwise be not less favourable than those for the time being provided by the said provisions, or any such amendment (but for no other purpose), the Ministry may, after consultation with the body charged with the administration of the Scheme, by order vary or amend the provisions of the Scheme ;

And whereas for the purposes mentioned in the said sub-section (6) it is necessary further to vary and amend the provisions of the Scheme,

And whereas the Insurance Unemployment Board is the body charged with the administration of the Scheme ;

Now, therefore, the Ministry, after consultation with the Insurance Unemployment Board, hereby makes the following Order :---

1. The provisions of the Scheme shall be varied and amended as follows :---

- (a) Clause 37 of the Scheme shall have effect as if in subclause (2) (c) thereof for the expression "for every five days" there were substituted the expression "for every eight days";
- (b) Clause 38 of the Scheme shall have effect as if in subclause (1) thereof for the word "six" where it occurs the word "three" were substituted.

2. This Order shall have effect from the 22nd March, 1937.

**3.**—(1) Nothing contained in sub-paragraph (a) of paragraph 1 of this Order shall affect the computation of the number of additional days in any claim year which began before 1st January, 1937;

(2) Nothing contained in sub-paragraph (b) of paragraph 1 of this Order shall entitle any person to receive benefit in respect of any day before the 25th March, 1937, to which he would not have been entitled if this Order had not been made.

4. This Order may be cited as the Unemployment Insurance (Insurance Industry Special Scheme) (Variation and Amerdment) Order (Northern Ireland), 1937, and this Order and the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1936, may be cited together as the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1937, and shall be construed as one.

Mercantile Marine.

THE UNEMPLOYMENT INSURANCE (MERCANTILE MARINE Exclusion) Regulations (Northern Ireland), 1937, DATED 28TH AUGUST, 1937, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOY-MENT INSURANCE ACT (NORTHERN IRELAND), 1936 (26 GEO. 5 and 1 Edw. 8, c. 30).

WHEREAS by virtue of the provisions of section 120 (3) of the Unemployment Insurance Act (Northern Ireland), 1936, the Special Orders set out in the Schedule hereto have effect as if they were Regulations made under section 106 of the said Act;

Now therefore the Ministry of Labour for Northern Ireland by virtue of the powers conferred on it by the said section 106, and of all other powers in that behalf, after consultation with the Board of Trade, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Unemployment Insurance (Mercantile Marine Exclusion) Regulations (Northern Ireland), 1937, and shall come into force on the date hereof.
