

(2) A consent for the purposes of these Regulations shall be signed by the person giving the consent and shall be registered with the Ministry at Stormont or such other place as the Ministry may direct, and shall remain in force until a withdrawal of consent by the person who gave the consent is similarly registered.

3. If any person is employed by or under the same employer partly in insurable employment and partly in some other employment the employer may consent to that person being treated as if he were wholly employed in insurable employment, and accordingly as from the date on which such consent is registered in accordance with Regulation 2 (2) hereof that person shall be treated as if he were wholly employed in insurable employment so long as the employment continues as aforesaid and so long as the consent remains in force.

Provided that this Regulation shall cease to apply to a person who is for thirteen consecutive weeks employed solely in employment which is not insurable employment.

4. If any person is employed by or under the same employer partly in agriculture and partly in other insurable employment, that person may consent to be treated as if he were wholly employed in agriculture or the employer may consent to that person being treated as if he were wholly employed in other insurable employment, and accordingly as from the date upon which such consent is registered in accordance with Regulation 2 (2) hereof that person shall be treated as if he were wholly employed in agriculture or wholly employed in other insurable employment, as the case may be, so long as the employment continues as aforesaid, and so long as the consent remains in force.

Provided that this Regulation shall cease to apply to any such person who is for thirteen consecutive weeks employed solely in agriculture or solely in other insurable employment, as the case may be.

### Payment of Travelling Expenses.

THE UNEMPLOYMENT INSURANCE (PAYMENT OF TRAVELLING EXPENSES) REGULATIONS (NORTHERN IRELAND), 1937, DATED 19TH MAY, 1937, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936 (26 GEO. 5 & 1 EDW. 8, C. 30).

The Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry") by virtue of the powers conferred on it by sections 110 and 111 of the Unemployment Insurance Act (Northern Ireland), 1936 (hereinafter referred to as "the Act"), and of all other powers in that behalf, hereby, with the consent of the Ministry of Finance, makes the following Regulations:—

1.—(1) These Regulations may be cited as the Unemployment Insurance (Payment of Travelling Expenses) Regulations (Northern Ireland), 1937, and shall have effect from the 19th May, 1937.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

(3) The Unemployment Insurance (Payment of Travelling Expenses) Regulations (Northern Ireland), 1930, (a) are hereby revoked, but such revocation shall not affect any right, privilege, obligation or liability acquired, accrued or incurred under those Regulations, or anything done or to be done thereunder.

2. Where any payment whether by way of grant or advance has been made out of moneys provided by Parliament to, or in respect of, any person, being an insured contributor in whose case the first statutory condition is fulfilled, on account of the expenses of travelling to any place for the purpose of obtaining employment, whether employment has or has not been found for that person at that place, the amount which the Ministry may, under section 110 of the Act, repay out of the Unemployment Fund to the Exchequer of Northern Ireland shall be one-half of the amount (if any) by which the said payment exceeds four shillings.
