ORDER, DATED 10TH DECEMBER, 1938, MADE BY THE MINISTRY OF  
AGRICULTURE UNDER SECTION 7(3) OF THE AGRICULTURAL  
MARKETING ACT (NORTHERN IRELAND), 1933.

1938. No. 138.

Whereas by sub-section (3) of Section 7 of the Agricultural Marketing Act (Northern Ireland), 1933, (hereinafter referred to as "the Act") it is provided, *inter alia*, that the Ministry of Agriculture for Northern Ireland (hereinafter referred to as "the Ministry") may by order require the board administering a scheme regulating the marketing of an agricultural product to impose a special levy or levies for the purpose of covering any loss which the board have experienced in trading under the scheme :

And whereas the Pigs Marketing Board (Northern Ireland) (hereinafter referred to as "the Board") are the Board administering the Pigs Marketing Scheme (Northern Ireland), 1933, being a scheme for the time being in force under the Act, and have experienced a loss in trading under the said scheme estimated at £109,750 during the period 6th December, 1937, to 10th December, 1938, inclusive :

And whereas a portion of this loss estimated at £61,250 has been met from the proceeds of the special levies imposed in pursuance of the provisions of the Pigs Marketing (Northern Ireland) (Special Levy) (No. 1) Order, 1938, the Pigs Marketing (Northern Ireland) (Special Levy) (No. 2) Order, 1938, the Pigs Marketing (Northern Ireland) (Special Levy) (No. 3) Order, 1938, the Pigs Marketing (Northern Ireland) (Special Levy) (No. 4) Order, 1938, the Pigs Marketing (Northern Ireland) (Special Levy) (No. 5) Order, 1938, the Pigs Marketing (Northern Ireland) (Special Levy) (No. 6) Order, 1938, and the Pigs Marketing (Northern Ireland) (Special Levy) (No. 7) Order, 1938 :

And whereas the uncovered portion of the total loss is accordingly estimated at £48,500 :

Now, therefore, the Ministry, in exercise of the powers conferred upon it by the said sub-section and of every other power enabling it in that behalf, hereby makes the following Order, that is to say :—

1.—The Board shall, during the period 12th December, 1938, to 7th January, 1939, inclusive, for the purpose of meeting the said uncovered portion of the total loss, impose a special levy of four shillings per pig upon all producers in the case of all sales of pigs by them to a curer or to the Board.

2.—This Order may be cited as the Pigs Marketing (Northern Ireland) (Special Levy) (No. 8) Order, 1938, and shall come into force on the 12th day of December, 1938.

## AIR-RAID PRECAUTIONS.

### Schemes.

THE AIR RAID PRECAUTIONS (SCHEMES) REGULATIONS, 1938, DATED 29th NOVEMBER, 1938, MADE BY THE MINISTRY OF HOME AFFAIRS WITH THE CONSENT OF THE MINISTRY OF FINANCE UNDER SECTION 10 (1) (c) OF THE AIR RAID PRECAUTIONS ACT, 1938 (2 GEO. VI, CH. 26).

The Ministry of Home Affairs, in exercise of the powers vested in it by the Air Raid Precautions Act, 1938, hereby makes the following Regulations:—

1.—The matters as to which Air Raid Precautions Schemes shall in particular contain provisions shall be the matters specified in the Schedule hereto.

2.—These Regulations may be cited as The Air Raid Precautions (Schemes) Regulations, 1938, and shall come into force forthwith.
