WHEREAS Orders entitled The Sea-Fishing Industry (Immature Sea-Fish) Order (Northern Ireland), 1933(a), and The Sea-Fishing Industry (Immature Sea-Fish) Order (Northern Ireland), 1934(b), were made by the Ministry of Commerce for Northern Ireland on the 9th December, 1933, and 8th May, 1934, respectively, under Section 1 of the Sea-Fishing Industry Act (Northern Ireland), 1933(c).

AND WHEREAS it is desirable for the purpose of maintaining supplies essential to the life of the community in the present emergency to revoke the said Orders.

Now, THEREFORE, the Ministry of Commerce for Northern Ireland, in exercise of its powers under the said section, hereby orders as follows:—

1.—The Sea-Fishing Industry (Immature Sea-Fish) Order (Northern Ireland), 1933, and The Sea-Fishing Industry (Immature Sea-Fish) Order (Northern Ireland), 1934, are hereby revoked.

2.—This Order may be cited as The Sea-Fishing Industry (Immature Sea-Fish) Revocation Order (Northern Ireland), 1939.

### Rate of Payment to Ministry of Commerce.

ORDER OF THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND, DATED JANUARY 2ND, 1939, UNDER SECTION 7 OF THE GAS REGULATION ACT, 1920, AS AMENDED BY SECTION 2 OF THE ELECTRICITY AND GAS (EXPENSES) ACT (NORTHERN IRELAND), 1923, PRESCRIBING THE RATE OF PAYMENT TO THE SAID MINISTRY FOR THE YEAR 1939.

Note: By this Order the Ministry of Commerce fixed the rate of payment to the said Ministry for the year 1939 at nine pence for each million cubic feet of gas sold during the year 1938.
