### · Protected Birds.

ORDER, DATED 12TH FEBRUARY, 1940, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION 5 OF THE WILD BIRDS PROTECTION ACT (NORTHERN IRELAND), 1931.

# 1940. No. 18.

Whereas it is provided (inter alia) by Section 5 of the Wild Birds Protection Act (Northern Ireland), 1931 (hereinafter referred to as "the Act"), that the Minister of Home Affairs may by order direct that the Act shall apply to any bird excepted from any Category from classification for special protection as if such bird were included in such Category;

AND WHEREAS it is provided by sub-section 1 of Section 16 of the Act that the Minister of Home Affairs shall have power to prescribe from time to time by Order any modifications of the previsions of the Act with respect to the special protection of the eggs and nests of birds;

AND WHEREAS it is further provided by sub-section 3 of Section 16 of the Act that such modifications may extend generally or to such district as may be specified in the Order;

And whereas representations have been made to the Minister of Home Affairs that such special protection as is afforded under the Act to the raven, its eggs and nest, should, as respects the districts of the Counties of Londonderry and Tyrone, be revoked for a period of three years;

AND WHEREAS in accordance with the provisions of sub-section 6 of Section 16 of the Act, notice of the proposal to make an Order, and the purport thereof, was duly given on the 1st day of January, 1940;

AND WHEREAS no objections to the making of the Order have been received;

Now, THEREFORE, I, THE RIGHT HONOURABLE SIR RICHARD DAWSON BATES, Baronet, Minister of Home Affairs, in pursuance of the powers vested in me by Section 5 of the Wild Birds Protection Act (Northern Ireland), 1931; and of all other powers in this behalf me thereunto enabling, hereby order and direct as follows, that is to say:—

- 1.—The Raven shall be added to the list of birds set out in Category I of the First Schedule to the Wild Birds Protection. Act (Northern Ireland), 1931, and accordingly shall not be entitled to the special protection afforded by the said Act.
- 2.—This Order shall be effective only in the district comprising the counties of Londonderry and Tyrone and shall remain in force for a period of three years from the 19th February, 1940, unless previously revoked.
