WHEREAS the Local Government Board for Ireland, in pursuance of the provisions of Section 5 of the Tuberculosis Prevention (Ireland) Act, 1908, made Regulations entitled the Tuberculosis (Procedure of Committees) Order, 1913 (hereinafter referred to as "the principal Order"):

AND WHEREAS the principal Order was amended by the Tuberculosis (Procedure of Committees) Order, 1933 :

AND WHEREAS it appears expedient that the principal Order should be further amended in manner hereinafter appearing :
