

Commerce for Northern Ireland may by order appoint, carry out any work in the course of a building undertaking or civil engineering contracting undertaking carried on by him unless there is in force a certificate issued by the said Minister that he is registered under the said Regulation, provided that the aforesaid provision shall not affect any servant of His Majesty acting in the course of his duty as such.

NOW, THEREFORE, I, THE RIGHT HONOURABLE SIR BASIL BROOKE, BARONET, Minister of Commerce for Northern Ireland, do by this order appoint the first day of October, nineteen hundred and forty-one, as the date for the purposes of the aforesaid provision.

Public Utility Undertakings.

ORDER, DATED 27TH NOVEMBER, 1941, MADE BY THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND UNDER REGULATION 56 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

1941. No. 195.

The Ministry of Commerce for Northern Ireland (hereinafter referred to as "the Ministry") by virtue and in exercise of the powers under Regulation 56 of the Defence (General) Regulations, 1939, delegated to the Ministry by the Secretary of State under Regulation 102A of the said Regulations, hereby orders and directs as follows:—

1.—(1) Subject to the provisions of this article, no person carrying on any undertaking of a class mentioned in the Schedule hereto shall publish, or permit to be published, copies of the accounts of that undertaking, or any report or other document relating to the operation of that undertaking which discloses information contained in those accounts.

(2) The directions given by this Order shall not relieve any such persons from any obligation to furnish the Ministry with a copy of such accounts, report or document as aforesaid, or prevent them from supplying copies thereof to any Government Department, or to any local authority, or to the auditors of the undertaking, or to such other persons as may be authorised in that behalf in writing by the Ministry.

(3) Any such accounts, reports and documents as aforesaid may be inspected at the office of the undertaking by any person who but for the directions given by this Order would have been entitled to receive

or inspect copies thereof and who shall have given to the undertaking notice in writing of his desire so to do not less than seven days previously.

2.—Any obligation to publish any account, report or other document referred to in this Order (including any obligation to lay such document before either or both Houses of Parliament) which is imposed by or by virtue of any Act or other instrument determining the functions of the undertakers, is hereby suspended ; and any other obligation or limitation so imposed is hereby relaxed so far as is necessary for compliance with the directions given by this Order.

3.—This Order may be cited as the Public Utility Undertakings (Prevention of Publications) (Northern Ireland) Order, 1941.

Any undertaking for the supply of electricity ;

Any canal, inland navigation, water transport, dock, harbour or pier undertaking.

ORDER, DATED 8TH APRIL, 1941, MADE BY THE MINISTRY OF LABOUR UNDER REGULATION 58A OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

The Ministry of Labour for Northern Ireland (hereinafter referred to as " the Ministry "), by virtue of the powers conferred on it by Regulation 58A of the Defence (General) Regulations, 1939, hereby makes the following Order :—

Short title

1.—This Order may be cited as the Undertakings (Restriction on Engagement) (Northern Ireland) Order, 1941.

Engagement
of agricul-
tural workers

2.—(1) Subject as hereafter provided, an employer shall not seek to engage or engage any male worker whose normal employment is employment in agriculture or whose current unemployment book issued under the provisions of the Unemployment Insurance Acts (Northern Ireland), 1936 to 1940, bears the industry letters ZTF, ZTG, ZVN or ZVO, except for work in agriculture ;
