or such part thereof as is necessary to show the number of stamps impressed by that machine.

- (6) No person shall impress upon a book any stamp except in accordance with the provisions of this Regulation".
- 5. In Regulation 16 of the principal Regulations the words "by reason of the affixing or impressing of stamps of the wrong kind" shall be substituted for the words "by reason of the affixing of stamps of the wrong kind".
- 6. In Regulation 17 of the principal Regulations the words "a stamp which has been affixed thereto or impressed thereupon" shall be substituted for the words "a stamp which has been affixed thereto".

## Emergency Powers (Excepted Employments).

REGULATIONS, DATED 12TH JANUARY, 1943, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE (EMERGENCY POWERS) ACT (NORTHERN IRELAND), 1939.

### 1943 No. 13

The Ministry of Labour for Northern Ireland by virtue of the powers conferred on it by the Unemployment Insurance (Emergency Powers) Act (Northern Ireland), 1939, and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance for Northern Ireland, hereby makes the following regulations:—

- 1.—(1) These regulations may be cited as the Unemployment Insurance (Emergency Powers) (Excepted Employments) Amendment Regulations (Northern Ireland), 1943, and shall be read as one with the Unemployment Insurance (Emergency Powers) (Excepted Employments) Regulations (Northern Ireland), 1942 (hereinafter referred to as "the principal regulations").
- (2) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 2.—The following regulation shall be inserted after regulation 2 of the principal regulations:—

"3.—(1) During the operation of these regulations part II of the First Schedule to the Unemployment Insurance Act (Northern Ireland), 1936 (which contains a general list of excepted employments) shall have effect as if there were included therein the following employment, that is to say—

employment by the Postmaster General of a scholar or student ordinarily receiving instruction at a school, college, university, or similar institution, where such employment commences and ends in any consecutive December and January, but does not continue for more than three weeks from and including the day of its commencement.

(2) This regulation shall be deemed to have had effect as from 1st December, 1942."
