" Section C.

Persons employed in foreign going ships other than fishing vessels.

29A. Where contributions are payable in respect of mariners employed in a foreign going ship other than a fishing vessel (not being mariners to whom the provisions of Regulation 29 of these Regulations apply) the employer shall pay such contributions at such times and in such manner as the Ministry may, from time to time, allow.

29B. Part II, Section A of Part III, and Regulations 23 and 24 of this Part of these Regulations shall, so far as they are not inconsistent with this Section of this Part of these Regulations, apply to mariners employed in a foreign going ship other than a fishing vessel (not being mariners to whom the provisions of Regulation 29 of those Regulations apply), with this modification, that the regular book of every person engaged for employment as a mariner in a foreign going ship other than a fishing vessel shall be dealt with in such manner as the Ministry may from time to time direct."

THE UNEMPLOYMENT INSURANCE (CONTRIBUTIONS) AMENDMENT REGULATIONS (No. 2) (NORTHERN IRELAND), 1943, DATED 22ND NOVEMBER, 1943, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936.

1943. No. 135.

The Ministry of Labour for Northern Ireland by virtue of the powers conferred on it by Section 15 of the Unemployment Insurance Act (Northern Ireland), 1936, and of all other powers in that behalf, hereby makes the following Regulations.

1.—(1) These Regulations may be cited as the Unemployment Insurance (Contributions) Amendment Regulations (No. 2) (Northern Ireland), 1943, and shall come into force on the date hereof, and these Regulations the Unemployment Insurance (Contributions) Regulations (Northern Ireland), 1937, (hereinafter referred to as the "principal Regulations") and the Unemployment Insurance (Contributions) Amendment Regulations (Northern Ireland), 1943, may be

cited together as the Unemployment Insurance (Contributions) Regulations (Northern Ireland), 1937 and 1943.

- (2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 2. In paragraph (1) of Regulation 8 of the principal Regulations the words "paid by the affixing or impressing of stamps to or upon the book so destroyed" shall be substituted for the words "paid by the affixing of stamps to the book so destroyed".
- 3. The following amendments shall be made in Regulation 10 of the principal Regulations:—
 - (a) In paragraph (1) the words "paid by the affixing or impressing of a stamp to or upon the regular book of the insured contributor" shall be substituted for the words "paid by the affixing of a stamp to the regular book of the insured contributor".
 - (b) In sub-paragraphs (a) and (b) of paragraph (2) the words "affix to or impress upon the regular book of the insured contributor" shall be substituted for the words "affix to the regular book of the insured contributor".
 - (c) In sub-paragraph (c) of paragraph (2) the words "time for affixing or impressing stamps to or upon the regular book of such person" shall be substituted for the words "time for affixing stamps to the regular book of such person".
 - (d) In paragraph (3) the words "to affix to or impress upon the regular book of the insured contributor" shall be substituted for the words "to affix to the regular book of the insured contributor".
 - (e) In paragraph (6) the words "No stamp shall be affixed to or impressed upon any unemployment book" shall be substituted for the words "No stamp shall be affixed to any unemployment book", and the words "any stamp affixed or impressed otherwise" shall be substituted for the words "any stamp affixed otherwise".
- 4. The following Regulation shall be inserted immediately after Regulation 10 of the principal Regulations:—
 - "10A.—(1) An employer who is liable to pay contributions in respect of any insured contributor employed by him may upon application to the Postmaster General and with the consent in writing of the Ministry and under and subject to a permit in that behalf issued by it pay the contributions in respect of such contributor by means of stamps impressed upon regular books by a machine and die approved by the Ministry.

- (2) An employer who pays contributions by means of impressed stamps as aforesaid shall—
 - (a) render from time to time, in such form as the Ministry may determine, a return of the number of insured contributors in respect of whom contributions have been or are to be paid by the means aforesaid, and of the number of contributions so paid;
 - (b) use the machine or die only in respect of insured contributors who are regular employees employed by him;
 - (c) pay the appropriate sum in respect of contributions at such Post Office as the Postmaster General may direct and at the same time produce the machine or such part of the machine as may be specified;
 - (d) allow the machine and die to be inspected at any reasonable time by any officer appointed by the Ministry or by the Postmaster General for that purpose; and
 - (e) observe such other conditions in respect of the use of the machine or die, or the treatment of, or the making of any entries on regular books on which stamps have been or are to be impressed as the Ministry may from time to time determine.
- (3) If it appears at any time that an employer has failed to comply with any of the above conditions, or that the impressions made by the machine or die are by reason of the nature thereof inadequate to show a proper representation of the stamp, or that the machine or die has become in any way defective, the Ministry may thereupon cancel or suspend its consent or permission.
- (4) An employer who elects to pay contributions by the method specified in this Regulation shall pay to the Ministry, or as the Ministry may direct, such fees as may be determined by the Ministry, with the concurrence of the Ministry of Finance, to represent the difference between the expenses in administration incurred by the Ministry by reason of the fact that the method has been adopted and the expenses which would have been incurred by the Ministry if the contributions had been paid by mean of adhesive stamps.
- (5) The first proviso to paragraph (2) of Regulation 7 of these Regulations shall not apply in the case of any regular book upon which stamps have been impressed and notwith-standing the provisions of that Regulation a regular book upon which stamps have been impressed shall be returned by the employer to the local office specified on the permit and the employer shall at the same time that such book is so returned produce or cause to be produced at the said office the machine

or such part thereof as is necessary to show the number of stamps impressed by that machine.

- (6) No person shall impress upon a book any stamp except in accordance with the provisions of this Regulation".
- 5. In Regulation 16 of the principal Regulations the words "by reason of the affixing or impressing of stamps of the wrong kind" shall be substituted for the words "by reason of the affixing of stamps of the wrong kind".
- 6. In Regulation 17 of the principal Regulations the words "a stamp which has been affixed thereto or impressed thereupon" shall be substituted for the words "a stamp which has been affixed thereto".

The Ministry of Labour for Northern Ireland by virtue of the powers conferred on it by the Unemployment Insurance (Emergency Powers) Act (Northern Ireland), 1939, and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance for Northern Ireland, hereby makes the following regulations:—

- 1.—(1) These regulations may be cited as the Unemployment Insurance (Emergency Powers) (Excepted Employments) Amendment Regulations (Northern Ireland), 1943, and shall be read as one with the Unemployment Insurance (Emergency Powers) (Excepted Employments) Regulations (Northern Ireland), 1942 (hereinafter referred to as "the principal regulations").
- (2) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
