Agricultural Seeds (Control).

Order, dated the Twentieth day of June, 1944, made by the Ministry of Agriculture under Regulation 55 of the Defence (General) Regulations, 1939.

1944. No. 51.

The Ministry of Agriculture for Northern Ireland (in this Order referred to as "the Ministry"), by virtue and in exercise of the powers under paragraph (1) of Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Delegation of Emergency Powers (Ministry of Agriculture for Northern Ireland) Order, 1943, made by the Secretary of State under paragraph (1) of Regulation 102 (A) of the said Regulations, hereby orders as follows:—

- 1. In this Order the following expression has the meaning hereby assigned to it, that is to say,
 - "Ryegrass" means a crop produced by sowing seed of Perennial Ryegrass or Italian Ryegrass or a mixture of Perennial and Italian Ryegrass.
- 2. Except under and in accordance with the terms of a licence granted by or on behalf of the Ministry no person, between the 21st day of June, 1944, and the 31st day of May, 1945 (both dates inclusive), shall harvest for seed any ryegrass from which a crop of seed has already been harvested.
 - 3. This Order shall apply only in Northern Ireland.
- 4. This Order shall come into force on the twenty-first day of June, 1944, and may be cited as the Ryegrass (Control of Harvesting) Order, 1944.

Corn, Feeding Stuffs, Oat Products and Ryegrass Seed: Records and Returns.

Order, dated 13th November, 1944, made by the Ministry of Agriculture under Regulations 55 and 55AA of the Defence (General) Regulations, 1939.

1944. No. 100.

The Ministry of Agriculture for Northern Ireland (in this Order

referred to as the "Ministry") by virtue and in exercise of the powers under paragraph (1) of Regulation 55 and paragraph (1) of Regulation 55AA of the Defence (General) Regulations, 1939, delegated to it by the Delegation of Emergency Powers (Ministry of Agriculture for Northern Ireland) (No. 2) Order, 1943, made by the Secretary of State under paragraph (1) of Regulation 102A of the said Regulations, and of all other powers enabling it in that behalf, hereby orders as follows:—

1. In this Order-

- (a) "Corn" includes barley, dredge corn, oats, rye and wheat.
- (b) Unless the context otherwise requires, expressions used in this Order, to which meanings have been assigned by any of the following Orders, that is to say, the Barley (Control and Prices) (Northern Ireland) Order, 1944; the Dredge Corn (Control and Prices) (Northern Ireland) Order, 1944; the Oats (Control and Prices) (Northern Ireland) Order, 1944; the Rye (Control and Prices) (Northern Ireland) Order, 1944; the Ryegrass Seed (Control) (Northern Ireland) Order, 1944; the Wheat (Control and Prices) (Northern Ireland) Order, 1944; the Feeding Stuffs (Control) (Northern Ireland) Order, 1944; and the Oat Products (Control and Maximum Prices) Order, 1943, or any other Order for the time being in force governing the obtaining or supplying of feeding stuffs, oat products, corn or ryegrass seed in Northern Ireland, shall have in this Order the meanings so assigned.
- 2. Every approved buyer shall furnish to the Ministry a return of his stocks, purchases and sales of oats grown in Northern Ireland during each week ending on Saturday, such return to be delivered to the Ministry not later than the Saturday following the week to which the return relates and to be in the form set out in the Schedule hereto or such similar form as the Ministry may require.
- 3. Every grower shall furnish to the Ministry such information relating to the production, threshing, use or disposal by him of any corn or ryegrass seed, threshed or unthreshed, grown by him, as the Ministry may from time to time require.
- 4. Every person shall furnish to the Ministry such returns relating to his dealings in corn, feeding stuffs, oat products and ryegrass seed as the Ministry may from time to time require.
- 5. Every person who is required by this Order or any other Order for the time being in force governing the obtaining or supplying of any corn, feeding stuffs, oat products or ryegrass seed, to keep or cause to

be kept, any record, shall retain it for one year from the date of the transaction to which it relates.

- 6. This Order shall come into force on the thirteenth day of November, 1944, and may be cited as the Corn, Feeding Stuffs, Oat Products and Ryegrass Seed (Records and Returns) (Northern Ireland) Order, 1944.
- 7. The Corn, Feeding Stuffs, Oat Products and Ryegrass Seed (Records and Returns) (Northern Ireland) Order, 1943, is hereby revoked but without prejudice to any proceedings in respect of any contravention thereof.
