the following scheme for amending the Public Elementary School Teachers' Superannuation Scheme, 1926, as amended by the Compensated Model School Teachers' Superannuation Scheme, 1927, the Compensated Model School Teachers' (Amendment) Scheme, 1927, the Teachers' (Public Elementary) Superannuation (Amendment) Schemes, 1930, 1936, 1939, 1940 and 1944, and all such schemes are hereinafter referred to as " the Principal Scheme as amended ".

1. This scheme shall apply to teachers who are entitled to have reckoned for pension purposes a period of non-contributing service under Article 3 or 4 of the Teachers' (Public Elementary) Superannuation (Amendment) Scheme, 1930, and who retire on or after the 1st day of April, 1944.

2. A teacher to whom this scheme applies shall be entitled to have reckoned in full for pension purposes (but not for the purpose of the additional allowance payable under Article 5 of the Teachers' (Public Elementary) Superannuation (Amendment) Scheme, 1944,) any period of non-contributing service heretofore reckonable at two-thirds of its actual duration under the Teachers' (Public Elementary) Superannuation (Amendment) Scheme, 1930.

3. Subject to the provisions of Article 1 hereof, this scheme shall apply to teachers who come under the terms of the Teachers' Superannuation (Reciprocal Arrangements) Schemes 1929 and 1935 and to other teachers having non-contributing service who re-enter the Principal Scheme as amended subsequent to the 1st day of April, 1929, only in so far as during their service in schools in Northern Ireland, Article 7 of the Teachers' (Public Elementary) Superannuation (Amendment) Scheme, 1930, has been applied to them; provided that any non-contributing service of such a teacher in excess of the period for which he has paid supplemental contributions shall be reckoned at two-thirds only of its actual duration.

4. This scheme may be cited as the Teachers' (Public Elementary) Superannuation (Amendment) Scheme, (No. 2), 1944.

WHEREAS a Scheme (hereinafter referred to as "the Principal Scheme") dated the 11th day of March, 1925, was framed by the Ministry of Finance in consultation with the Ministry of Education, in pursuance of Section 70 of the Education Act (Northern Ireland), 1923

(hereinafter referred to as "the Act of 1923"), and was approved by Order in Council on the 29th day of May, 1925 :

AND WHEREAS the Amending Scheme has been laid before both Houses of Parliament and neither such House has within the period prescribed in that behalf by Section 71 of the Act of 1923, as amended by Section 4 of the Rules Publication Act (Northern Ireland), 1925, presented an Address praying the Governor of Northern Ireland to withhold his assent from the Amending Scheme :

Now I, JAMES ALBERT EDWARD, DUKE OF ABERCORN, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred upon me by Section 71 of the Act of 1923, do hereby approve of the Amending Scheme.

# SCHEDULE.

In pursuance of Sections 70 and 71 of the Education Act (Northern Ireland), 1923, the Ministry of Finance in consultation with the Ministry of Education, hereby frames the following Scheme for amending the Teachers' (Secondary and Preparatory) Superannuation Scheme, 1925, as amended or applied by the Teachers' (Secondary and Preparatory) Superannuation (Amendment) Scheme, 1926, the Training College Teachers' Superannuation Scheme, 1927, the Teachers' (Secondary and Preparatory) Superannuation (Amendment) Scheme, 1926, the Training College Teachers' Superannuation (Amendment) Scheme, 1930, the Teachers' (Miscellaneous) Superannuation Scheme, 1930, the St. Mary's Training College, Belfast, Superannuation Scheme, 1934, the Teachers' (Miscellaneous) Superannuation (Amendment) Scheme, 1936, the St. Mary's Training College, Belfast, Superannuation (Amendment) Scheme, 1936, and the Teachers' (Secondary and Preparatory) Superannuation (Amendment) Schemes, 1937, 1939 and 1940, and all such Schemes are hereinafter referred to as "the Principal Scheme as amended ".

PART I. ADDITIONAL ALLOWANCE FOR TEACHERS RETIRED BEFORE 1ST JULY, 1936.

1. There shall be granted to a teacher who retired with a pension or gratuity before the 1st day of July, 1936, and who was alive on the 2nd day of November, 1943, an additional allowance equal to one-thirtieth of the average annual salary, computed as in the Principal Scheme as amended, multiplied by the number of completed years of service ascertained by adding to one-half of the period of service given before the date of admission to the Principal Scheme as amended the full period of service given on or after that date, provided that the total additional allowance so payable shall in no case exceed one and a half times the average annual salary.

2. The amount of the additional allowance payable under Article 1 hereof shall be abated by the amount of contributions calculated at the rate of one and a half per cent. per annum on the teacher's retiring salary for the period of his service given between the date of admission to the Principal Scheme as amended and the date of retirement.

PART II. ADDITIONAL ALLOWANCE FOR TEACHERS RETIRED AFTER 1ST JULY, 1936, AND FOR EXISTING PENSIONABLE TEACHERS.

3. This Part of the Scheme shall apply to :--

Е

- (1) teachers who retired on pension or gratuity on or after the 1st day of July, 1936;
- (2) teachers who are in pensionable service or temporarily out of pensionable service at the date of this Scheme (hereinafter referred to as "existing pensionable teachers"); and who had pensionable service before the date of admission to the Principal Scheme as amended.

4. There shall be granted to a pensioner to whom this Part of the Scheme applies or to an existing pensionable teacher who retires and is eligible for pension or gratuity under the Principal Scheme as amended, an additional allowance equal to onethirtieth of the average annual salary computed as in the Principal Scheme as amended multiplied by one-half of the number of years of service given before the date of admission to the Principal Scheme as amended, provided that the total additional allowance payable under the Principal Scheme as amended and this Scheme shall in no case exceed one and a half times the average annual salary.

5. Any fraction of a year in excess of the number of completed years in the one-half of the period of service given before the date of admission to the Principal Scheme as amended, may, if necessary, be added to a fraction of a year in excess of the number of completed years of service given after that date for the purpose of making up a further completed year of service for the calculation of the additional allowance under this Scheme and the Teachers' (Secondary and Preparatory) Superannuation (Amendment) Schemes, 1936 and 1940 (hereinafter referred to as "the 1936 Scheme" and "the 1940 Scheme" respectively).

Provided that where the additional allowance is so payable in respect of a further completed year of service, the amount shall be reduced by the amount, if any, paid under the provisions of Article 5 of the 1936 Scheme.

### EDUCATION.

#### PART III. GENERAL.

6. The amount of additional allowance when payable to a legal personal representative shall be abated by the amount, if any, paid under Article 15 (1) of the Teachers' (Secondary and Preparatory) Superannuation Scheme, 1925.

7. Subject to the provisions hereof, this Scheme shall apply to-

- a teacher who comes under the terms of the Teachers' Superannuation (Reciprocal Arrangements) Scheme, 1929, as amended by the Teachers' Superannuation (Reciprocal Arrangements) (Amendment) Scheme, 1935, only in so far as during his service in schools in Northern Ireland he shall have paid contributions under Article 4 of the 1940 Scheme.
- (2) a pensioner who, at the date of his retirement on pension, came under the provisions of the said Reciprocal Arrangements Schemes.

8. The expression "pension" in the Principal Scheme as amended shall be deemed, unless the contrary intention is apparent, to include the additional allowance under this Scheme.

- In Article 2 of the 1940 Scheme the words "excluding non-contributing service" in line 6 of that Article shall be deleted.
  - (2) Article 9 of the 1940 Scheme (which provided for the postponement of the payment of additional allowances under that Scheme until after the end of the period of the present emergency) is hereby cancelled, and the payments provided for under that Scheme shall be made forthwith.

10. This Scheme may be cited as the Teachers' (Secondary and Preparatory) Superannuation (Amendment) Scheme, 1944.
