We, The Right Honourable Sir James Andrews, Baronet, Lord Chief Justice of Northern Ireland, The Right Honourable Sir Anthony Brutus Babington, Knight, one of the Ordinary Judges of His Majesty's Court of Appeal in Northern Ireland, and Alexander Stewart Merrick, President of the Incorporated Law Society of Northern Ireland (being the persons in that behalf authorised by section two of the Solicitors' Remuneration Act, 1881, as amended by section 51 of The Solicitors' Act (Northern Ireland), 1938), do in pursuance and execution of the powers given to us by the said statutes and of all other powers and authorities enabling us in that behalf order and direct as follows:—

The remuneration of a Solicitor in respect of all business undertaken after the 29th day of February, 1944, the remuneration for which is regulated by Clause 2 of the General Order made under the first above-mentioned Act which came into force on the first day of June, 1884, and by Clause 1 of the like Order dated the 17th day of May, 1920, shall with the exception of business referred to in Rule 5 of the Rules applicable to Part 2 of Schedule I to the first above-mentioned Order be increased by an addition of sixteen and two-thirds per centum calculated on the sums now respectively chargeable in respect of the charges authorised

REGULATIONS, DATED 4TH DAY OF JULY, 1944, MADE BY THE MINISTRY OF LABOUR UNDER SECTION 24 OF THE TRADE BOARDS ACT (NORTHERN IRELAND), 1923, AS EXTENDED BY THE TRADE BOARDS ACT (NORTHERN IRELAND), 1944.

1944. No. 64.

The Ministry of Labour in pursuance of the powers conferred on it by Section 24 of the Trade Boards Act (Northern Ireland), 1923, as extended by the Trade Boards Act (Northern Ireland), 1944, and of every other power enabling it in that behalf, hereby makes the following Regulations:—

- 1. The Trade Boards (Notices) Regulations (Northern Ireland), 1939, (a) shall apply to the fixing, cancellation or variation of a guaranteed time-rate pursuant to the Trade Boards Act (Northern Ireland), 1944, in like manner as they apply to the fixing, cancellation or variation of any minimum rate mentioned in Regulation 2 of the said Regulations and, accordingly, references in the said Regulations to any such minimum rate shall be construed as including references to a guaranteed time-rate fixed, cancelled or varied in pursuance of the said Trade Boards Act (Northern Ireland), 1944.
- 2. The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
