PARLIAMENTARY ELECTORS WAR-TIME REGISTRATION

ORDER, DATED 5TH FEBRUARY, 1945, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION ONE OF THE PARLIAMENTARY ELECTORS (WAR-TIME REGISTRATION) ACT (NORTHERN IRELAND), 1944.

WHEREAS it is provided by sub-section (2) of Section One of the Parliamentary Electors (War-Time Registration) Act (Northern Ireland), 1944, that the expression " war election " means, for the purposes of the said Act, an election initiated on or after the appointed day and before the expiration of the National Registration Act, 1939, not being a University Election.

AND WHEREAS it is provided by sub-section (1) of Section Twenty-One of the said Act that the expression " appointed day " means such day as may be appointed by Order of the Minister of Home Affairs.

NOW, THEREFORE, I, THE RIGHT HONOURABLE JOHN EDMOND WARNOCK, K.C., Minister of Home Affairs for Northern Ireland, do hereby order as follows :—

The appointed day, within the meaning of sub-section (2) of Section One of the Parliamentary Electors (War-Time Registration) Act (Northern Ireland), 1944, shall be the 1st day of April, 1945.

Medicines, Pharmacy and Poisons Act : Appointed Days

ORDER, DATED 30th MAY, 1945, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION 40 OF THE MEDICINES, PHARMACY AND POISONS ACT (NORTHERN IRELAND), 1945.

1945. No. 64

WHEREAS it is provided by Section 40 of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945 (hereinafter referred to as "the Act") that the Act shall come into operation on the appointed day, and that the appointed day shall be such day as the Minister of Home Affairs may appoint, and that different days may be appointed for different provisions of the Act :

NOW, THEREFORE, I THE RIGHT HONOURABLE EDMOND WARNOCK, Minister of Home Affairs for Northern Ireland, do hereby order as follows :—

1. The first day of July, one thousand nine hundred and forty-five shall, save as hereinafter in this Order provided, be the appointed day for the coming into operation of the provisions of the Act.

2. The first day of July, one thousand nine hundred and forty-six shall be the appointed day for the coming into operation of the provisions of Section 4 of the Act.

3. The first day of January, one thousand nine hundred and forty-seven shall be the appointed day for the coming into operation of the provisions of Section 10 of the Act.
