REGULATIONS, DATED 8TH MARCH, 1945, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1923 TO 1942, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

1945. No. 33

1.—These Regulations may be cited as the Nursery Schools Regulations, 1937, Amending Regulations, No. 3, 1945.

2.—The Nursery Schools Regulations, 1937 (Statutory Rules and Orders of Northern Ireland, 1937, No. 30), as amended by Statutory

Rules and Orders of Northern Ireland, 1938, No. 133; and 1943, No. 23; which Regulations, as so amended, are hereinafter referred to as the "Principal Regulations", are hereby amended as follows:—

3.—Article 15 of the Principal Regulations is hereby amended by the addition of the following clause after the words "£145 per annum (together with, in the case of a Superintendent, Principal's Grant)":—

The rate of salary payable to a Superintendent or Assistant Superintendent appointed under Article 13 (*b*) of the Principal Regulations shall in respect of service as such, given on and after 1st April, 1944, be increased by twenty-five per cent. : save that the increase shall not be such as to raise the salary of the said Superintendent or Assistant Superintendent above that to which a Superintendent or Assistant Superintendent of the same length of service who was recognised under Article 13 (*a*) of the Principal Regulations would be entitled.

4.—These Regulations shall be construed with and as forming part of the Principal Regulations.

REGULATIONS, DATED 22ND JANUARY, 1945, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1923 TO 1942.

1. These Regulations may be cited as the Public Elementary Schools Regulations, 1934, Amending Regulations, No. 20, 1945.

The Public Elementary Schools Regulations, 1934 (Statutory Rules and Orders of Northern Ireland, 1934, No. 40), as amended by Statutory Rules and Orders of Northern Ireland, 1935, No. 69; 1936, No. 83; 1936, No. 159; 1937, No. 17; 1937, No. 57; 1937, No. 87; 1938, No. 28; 1938, No. 63; 1938, No. 125; 1939, No. 79; 1940, No. 21; 1941, No. 73; 1942, No. 43; 1942, No. 47; 1942, No. 192; 1943, No. 73; 1944, No. 12; 1944, No. 90; and 1944, No. 108; which Regulations as so amended are hereinafter referred to as the "Principal Regulations", are hereby amended as follows:—

3. Clause (*a*) of Article 199 of the Principal Regulations is hereby amended by the deletion of the words "and are recommended by the Inspector in accordance with Article 209 (*b*) hereof",
