

apply to any work carried out for a purpose specified in the Table set out in Part V of the said Schedule.

(2) In this order, the expression " a property " means, in relation to any work carried out at any time—

- (a) any property the full value of which was ascertained for the purposes of an assessment under Schedule A in force at that time ; or
- (b) any property which, not being or forming part of a property to which sub-paragraph (a) of this paragraph applies, was at that time the subject of a valuation shown in the Valuation List for the time being in force under the Valuation Acts (Northern Ireland), 1852 to 1940 ; or
- (c) in a case where the work is carried out on property which is not and does not form part of a property to which sub-paragraph (a) or sub-paragraph (b) of this paragraph applies, the building or site on which the work is carried out, together with any land or building occupied with that building or site :

Provided that, where any building which would constitute a property for the purposes of this order comprises two or more parts which are occupied or constructed for occupation as separate dwellings, each of those parts shall be deemed to be a separate property for the said purposes and the remainder of the building shall also be deemed for the said purposes to be a separate property.

4.—The Control of Building Operations (Northern Ireland) Order, 1942 is hereby revoked.

5.—This order may be cited as the Control of Building Operations (Northern Ireland) Order, 1945.

Pre-Cast Building Units

1945. No. 95

The Ministry of Finance for Northern Ireland, in exercise of the powers under Regulation 55 of the Defence (General) Regulations, 1939, delegated to the Ministry by the Secretary of State, hereby orders as follows :—

1. This Order applies to any person producing any pre-cast concrete walling units other than units which are of such a shape, size or weight that they can be manipulated by one hand.

2. Every person to whom this Order applies shall, not later than the 25th August, 1945, furnish the following information to the Ministry of Finance :—

- (i) His name ;
- (ii) The address at which the production takes place ;
- (iii) Particulars of the types of pre-cast concrete walling unit produced ;
- (iv) Particulars of the number of each type of unit produced during the twelve months ended on 30th June, 1945 ;
- (v) Description of any other business carried on at the same premises.

3. This Order may be cited as the Pre-Cast Building Units Order (Northern Ireland), 1945.

CONDITIONS OF EMPLOYMENT AND NATIONAL ARBITRATION

ORDER, DATED 6TH FEBRUARY, 1945, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER REGULATION 58AA OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

The Ministry of Labour for Northern Ireland in exercise of the powers conferred on it by Regulation 58AA of the Defence (General) Regulations, 1939, hereby makes the following Order :—

1.—Article 5 of the principal Order (which relates to recognised terms and conditions of employment) shall have effect as if—

(1) in paragraph (1) thereof, for the words “ there are in force terms and conditions of employment ” there were substituted the words “ terms and conditions of employment are established ” ;

(2) in paragraph (3) thereof, for the words “ is observing ” in both places where those words occur, there were substituted the words “ is or was observing. ”, after the words “ which are ” there were inserted the words “ or were ”, and after the words “ that question may be reported to the Ministry ” there were inserted the words “ at any time within twelve months of the date on which the question first arose ” ; and
