The Ministry of Commerce for Northern Ireland (hereinafter referred to as "the Ministry") in pursuance of Article 8 of the Furniture (Control of Manufacture and Supply) (Northern Ireland) Order, 1945 (a), hereby issues the following directions:—

- A manufacturer who applies the utility mark to any furniture referred to in paragraph 1 of the First Schedule to the said Order (as amended by a subsequent Order (b), being furniture manufactured by him under the authority of a licence issued or having effect under that Order, and referred to in that licence as utility furniture, shall apply thereto the identification number notified to him by or on behalf of the Ministry for the purposes of this paragraph, or of paragraph 1 of the Domestic Furniture (Utility Mark) (Northern Ireland) Directions, 1944 (c).
- 2. A manufacturer who applies the utility mark and identification number to any such furniture shall, unless the contrary be expressly provided in the second column of the Schedule hereto, apply that mark and number by means of a stamp approved on behalf of the Ministry for that purpose; where, under the provisions of that Schedule, the utility mark is to be applied by means of a transfer or label, the dimensions of that mark shall not be smaller than those of the mark shown in the Second Schedule to the said Order.
- In respect of an article of furniture specified in the first column of the Schedule hereto, the utility mark and identification number shall be applied in the place specified in the second column thereof in relation to that article.
- 4. A manufacturer who applies the utility mark and identification number to any article of furniture shall apply them before he supplies that article to any other person.
- The Domestic Furniture (Utility Mark) Directions, 1944 (c), are hereby revoked.

Description of Article.	Position of Utility Mark and Identification Number.
Wardrobe	Inside of wardrobe end centred approximately three inches below the hanging rail:
Dressing Chest	Centre of upper side of drawer rail below top drawer and, by means of a transfer, on painted back of mirror, if any.
Tallboy	Centre of inside end of cupboard part.
Bedstead	Centre of back of head end; centre of inside of foot end; centre of side of each long angle of the combination mattress and on one long side of frame of woven wire mattress. Wherever applied to a metal surface, the mark and number shall be applied by means of a transfer.
Settee ,	By means of a label fixed with 4 gimp pins to centre of underside of bottom front frame rail.
Bed-Settee	Inside of each front leg.
Divan	Centre of outside headboard and inside stump leg at head end and by means of a label sewn at centre of overlay.
Kitchen Table	Centre of underside of top.
Kitchen Cabinet (top part)	Centre of top rail inside one door.
Kitchen Cabinet (bottom part)	Centre of top rail inside door.
Kitchen Chair	Centre of underside of seat.
Sideboard	Centre of inside of each cupboard bottom.
Dining Table	Centre of underside of each leaf.
Dining Chair	Centre of inside of back seat rail and centre of underside of seat.
Open-Arm Easy Chair	Centre of underside of one arm rest.
Stuffover Easy Chair	By means of a label sewn to centre of underside of seat.
Stuffover Easy Chair (Model No. 9UA, 10UA and 11UA)	By means of a label fixed with 4 gimp pins to centre of underside of bottom front frame rail.

Description of Article.	Position of Utility Mark and Identification Number.
Adjustable Fireside Chair	Centre of middle seat lath and by means of a label sewn to back edge of loose cushion.
Bed Chair	Centre of one lath and by means of two labels, the one sewn in the joint between the two cushions and the other in the border of the loose cushion.
Set of Shelves	Centre of underside of top shelf.
Occasional Table	Centre of underside of top.
Cot	Centre inside of long back rail at bottom and underside of mattress frame at centre of long rail.
Playpen	Centre inside of one long bottom rail.
High Chair, Convertible High Chair, and Child's Low Chair	Centre of underside of seat.
Curb	Centre of underside of long section.

EXPLANATORY NOTE.

These Directions revoke and re-enact, with certain additions and amendments (printed in italics in the Schedule) the Domestic Furniture (Utility Mark) Directions 1944 (S. R. & O. (N.I.) 1944, No. 97). The new Order is rendered necessary on account of the introduction of additional items of furniture introduced into the utility range in Northern Ireland.
