

**Remuneration of Officers**

THE ELECTORAL (REMUNERATION OF OFFICERS) REGULATIONS (NORTHERN IRELAND), 1946, DATED 9TH MAY, 1946, MADE BY THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND, WITH THE CONCURRENCE OF THE MINISTRY OF FINANCE FOR NORTHERN IRELAND, UNDER SUB-SECTION (1) OF SECTION THIRTY-NINE OF THE ELECTIONS AND FRANCHISE ACT (NORTHERN IRELAND), 1946.

In pursuance of the powers conferred by sub-section (1) of Section Thirty-nine of the Elections and Franchise Act (Northern Ireland), 1946, and all other powers it thereunto enabling the Ministry of Home Affairs for Northern Ireland hereby makes the following regulations :—

1. The several officers mentioned in the Schedule to these Regulations shall be entitled to receive for the performance of the registration duties imposed on them by or under the provisions of the Elections and Franchise Act (Northern Ireland), 1946, the sums respectively specified in that behalf in the said Schedule.

2. These Regulations are made without prejudice to the power of the said Ministry subsequently to prescribe remuneration for the said officers in respect of their duties as Parliamentary Returning Officers under the said Act.

3. These Regulations may be cited as the Electoral (Remuneration of Officers) Regulations (Northern Ireland), 1946.

**Local Government Elections : Returning Officers Certificate**

REGULATIONS, DATED 30TH AUGUST, 1946, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER THE ELECTIONS AND FRANCHISE ACT (NORTHERN IRELAND), 1946.

1946. No. 129

The Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by Section Fifty-four of the Elections and Franchise Act (Northern Ireland), 1946, and of all other powers in that behalf thereunto enabling the Ministry, hereby makes the following Regulations, that is to say :—

1. A certificate given by the Returning Officer at any Local Government Election in accordance with the provisions of Sub-Section 7 of Section Twenty-three of the Elections and Franchise Act (Northern Ireland), 1946, shall be in the form set out in the Schedule hereto, or in a form to the like effect.

2. These Regulations may be cited as the Electoral (Returning Officer's Certificate) Regulations (Northern Ireland), 1946.
