5. This scheme may be cited as the Teachers' (Secondary and Preparatory) Superannuation (Amendment) Scheme, 1947, and save where otherwise provided shall come into operation on the first day of April, 1947.

### Technical Teachers : Salary Grants

REGULATIONS DATED 16TH JANUARY, 1947, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1923 TO 1942, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

1947. No. 8

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by sections 65, 69 and 77 of the Education Act (Northern Ireland), 1923; and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Technical Teachers (Salary Grants) Regulations (Northern Ireland), 1947.

(2) In these Regulations the expression "the principal Regulations" means the Regulations for Technical Teachers, Northern Ireland, 1937, as amended by subsequent Regulations other than these Regulations.

(3) These Regulations shall be construed as one with the principal Regulations.

2. The principal Regulations shall have effect subject to the following provisions of these Regulations.

3.—(1) Subject to the provisions of paragraph (2) of this Regulation and of Regulation 45 of the principal Regulations, the Ministry shall pay to the managers in respect of the financial year ending on the 31st March, 1947, and of the financial year ending on the 31st March, 1948, a grant (hereinafter referred to as a "salary grant") consisting of—

(a) an amount equal to the sum of the increment grant and war bonus grant paid to the managers by the Ministry in the financial year ended on the 31st March, 1945, under the principal Regulations; and

(b) an amount equal to ninety per cent. of the sum by which the salaries and allowances payable by the managers under the principal Regulations in respect of the financial year ending on the 31st March, 1947, or the 31st March, 1948, as the case may be, exceed the salaries and allowances (including war bonus) paid by the managers under those Regulations in the financial year ended on the 31st March, 1945.

(2) The Ministry shall have power to deduct the amount of the teachers' pension contributions from the salary grant or any other grant payable to the managers by the Ministry if, for any reason, the said amount be not paid over to the Ministry when due, and shall pay any sum so deducted into the superannuation fund.

(3) Regulation 31 of the principal Regulations shall not apply as respects grants payable in respect of the financial years ending on the 31st March, 1947, and the 31st March, 1948.

(4) In this Regulation the expression "managers" does not include any managers other than an education authority.

4. In Regulation 2 of the principal Regulations, the definitions of the expressions "increment grant," "basic rate," "basic portion" and "incremental portion" shall cease to have effect; and in Regulations 36 and 45 of those Regulations for any reference to an increment grant there shall be substituted a reference to a salary grant.
